MEMORANDUM**

To: Law Students

Re: Registration for Spring Semester
Date: November 7, 2001

The schedule for the spring semester which now appears on the Law School web page and on hard copy on the downstairs bulletin boards is essentially the same as that which was circulated last spring in preparation for registration for the fall semester. Course descriptions appear in the Law School Student Handbook on the web. In addition to the separate memoranda describing the spring minicourses, I offer the following information, about courses and adjunct and visiting professors, which may be helpful to you in the registration process.

Business Crimes, while a two-credit course, will meet extra time weekly as indicated on the schedule until March 29, when Professor Ponsoldt will be leaving the country to fulfill a professional obligation. He will return in time for the final exam.

Copyright Problems Seminar offered by Dean Shipley and the **Intellectual Property Seminar** offered by Professor Heald are different course and a student may take either of them or both of them.

Corporate Tax which is normally a four-credit course will be offered as a 3-credit course by Professor Howard Abrams of the Emory Law School. As noted on the schedule, this course will be offered only if at least 10 students enroll in it by the end of the first registration period in December.

Criminal Procedure II, while a three-credit course, will meet four times weekly until March 29, when Professor Ponsoldt will be leaving the country to fulfill a professional obligation. He will return in time for the final exam.

Environmental Practice Seminar, which has been taught for a number of years as a minicourse, will be offered for the first time this spring as a two-credit course. As in the past, it will be taught by Adjunct Professors Holly Hill and Doug Henderson. Also, as in the past, the basic Environmental Law course is a pre-requisite.

Estate Planning Seminar will be offered as a two-credit course by Professor Spurgeon, rather than the three-credit form in which it has been offered in the past.

Property Seminar offered by Professor Smith will examine various theories of property law, including Locke's labor theory, natural rights, economic and utilitarian approaches, and modern communitarian perspectives. Each student will prepare a major research paper. Any topic dealing with property (real property, personal property, or intangible property) is suitable for a paper, provided the paper explores one or more theoretical approaches.

Trademark Law will be offered as a two-credit course by Adjunct Professor Ted Davis, rather than the ordinary three-credit offering.

**Visiting Professors
Spring Semester, 2002**

Howard Abrams (Corporate Tax) is a member of the Emory Law School faculty, where he has taught since 1991. A graduate of Harvard Law School, he has been a visiting professor at the University of Oklahoma and Cornell. He has taught various courses here since 1994 and is the author of a leading casebook in the fields of corporate and partnership taxation. He is a member of the American Law Institute.

Victor Flatt (Administrative Law) is an Associate Professor at the Georgia State College of Law, where he has taught since 1995. His undergraduate degree is from Vanderbilt (Phi Beta Kappa) and his J.D. is from Northwestern Law School (Order of the Coif). Upon graduation, he served as a judicial law clerk in the United States Sixth Circuit Court of Appeals and worked in a major Seattle law firm before joining the University of Washington Law Faculty in 1993.

**Adjunct Professors
Spring Semester, 2002**

Patricia Barron (Interviewing, Counseling and Negotiation) was Director of the Gainesville, Ga. office of Georgia Legal Services for over 10 years and worked for Legal Services for 18 years. A 1979 graduate of Georgetown Law School, she also has served as Director of the Law School's Family Violence Clinic. She is currently Associate Magistrate in Athens-Clarke County.

J. Ralph Beard (Arbitration Seminar) is Dean Emeritus of the Law School and a long-time faculty member. Currently a member of the Athens firm of Blasingame, Burch, Garrard & Bryant, Mr. Beard served in Solicitor's Office of the United States Labor Department.

Mark Cooney (Sociology of Law) has an S.J.D. from Harvard Law School and a PhD. in Sociology from the University of Virginia. He is an Assistant Professor in the Department of Sociology at the University of Georgia. He has taught this course for the last several years at the Law School.

Theodore Davis (Trademark Law) is a partner at the Kilpatrick, Stockton law firm in Atlanta. Having earned his undergraduate degree *cum laude* from Davidson College, he is a 1990 graduate of the University of Virginia Law School, where he was a Notes Editor of the *Virginia Law Review*. He has served as an adjunct professor at the Emory Law School and has published many articles in such journals as the *University of Virginia Law Review*, *University of Minnesota Law Review* and *Washington & Lee Law Review*.

Bertis Downs (Entertainment Law) is a graduate of the Law School (1981) and served as law clerk to Judge Wilson Cowen of the Court of Appeals for the Federal Circuit. He has taught at the Law School for a number of years and has lectured throughout the country on Entertainment Law and Sports Law. He is General Counsel to R.E.M./Athens, Ltd.

Laurie Fowler (Environmental Law Practicum) is a 1983 graduate of the Law School. She has taught various environmental law courses here for many years. After serving as Director of the Georgia Environmental Policy Institute, which provided legal and technical assistance to state and local governments in the area of pollution prevention, she now is a member of the faculty of the Institute of Ecology at the University.

Steve Harper (Trial Practice) is Assistant Director of the Institute for Continuing Legal Education in Athens. He is a graduate of the United States Military Academy and the University of Alabama Law School. He previously taught at West Point and was the Staff Judge Advocate at Fort Gordon. He has tried cases and served as a trial judge while in the Judge Advocate General's Corps.

Doug Henderson (Environmental Practice) is a partner in the Environmental Practice group at the Troutman, Sanders law firm in Atlanta. He earned his undergraduate degree

at George Washington University and his law degree from the University of Kentucky. He also holds graduate degrees from Georgia Tech and the University of Michigan.

Holly Hill (Environmental Practice Minicourse) is an Order of the Coif graduate of the Law School (1988), where she served on the Editorial Board of the *Georgia Law Review*. As an environmental law attorney in the Atlanta law firm of Troutman, Sanders, she advises clients on regulatory compliance with federal and state environmental laws and represents clients in environmental litigation regarding cost recovery actions, insurance coverage site contamination, and toxic tort claims.

Charles Kuck (Immigration Law) has taught here for several years as an adjunct. . He is a partner at the Littler, Mendelsohn law firm in Atlanta. He is a 1989 graduate of the Arizona State University Law School and is a former chair of the Arizona Bar Association's Immigration Law Section.

Ken Mauldin (Trial Practice) has taught as an adjunct for a number of years. He is a 1980 graduate of the Law School and served as Solicitor of the State Court of Clarke County until 2000 when he was elected District Attorney for the Western Circuit. He earned his LL.M. in 1989 from Emory Law School and has taught trial practice here at the Law School for a number of years. He has served as president of the Solicitors' Association of Georgia.

Jeffrey Netter (Law and Economics) is Professor of Finance at the University's Terry School of Business. His law degree is from Emory and his PhD. in Economics is from Ohio State. In addition to teaching this course at the Law School for several years, he has taught at the University of North Carolina and the University of Michigan.

Michael Rodgers (Community Association Law) practices in the commercial real estate law field with the Seyfarth, Shaw law firm in Atlanta. He is a graduate of the Emory University Law School, having earned his undergraduate degree at the College of William & Mary. He was Assistant Editor of *Community Association Law: Cases and Materials on Common Interest Communities*. He taught this course here during the last academic year.

Stephen Schaezel--Mr. Schaezel (Patent Law), a 1982 graduate of the Law School, is a partner in the Atlanta law firm of Kilpatrick Stockton. He has an engineering degree from Georgia Tech and has been teaching the Patent Law course here at the Law School since 1989.

Geoffrey Sutcliffe (Patent Law) is a partner in the Intellectual Property practice group at Kilpatrick Stockton. He was previously a Patent Examiner with the United States Patent and Trademark Office, where he examined applications in the electrical communications and optical telecommunications arts, and then was a patent agent. His undergraduate degree was earned with honors from Auburn University in Electrical Engineering. His J.D. from Georgetown was awarded in 1994.
