### new titles



Dan T. Coenen University Professor & Harmon W. Caldwell Chair in Constitutional Law B.S., University of Wisconsin J.D., Cornell University

Dan T. Coenen has recently been named the new holder of the Harmon W. Caldwell Chair in Constitutional Law at the University of Georgia. He also carries the title of University

Professor, which is a permanent designation awarded to no more than one UGA professor campus-wide each year and is reserved only for those who have had a significant impact on the university in addition to fulfilling their normal academic responsibilities.

Coenen has served on the UGA law faculty since 1987. A professor in the areas of constitutional law and contracts, he received the Josiah Meigs Award – UGA's highest honor for excellence in teaching – in 1998. Two years later, he was inducted into the university's elite Teaching Academy and was elected as a member of the organization's executive committee the following year. Additionally, he has received 19 awards and recognitions from the law school's student body.

Coenen's scholarship includes his recent book *The Story of* The Federalist: *How Hamilton and Madison Reconceived America*. His many scholarly articles and essays have appeared in publications such as *The Yale Law Journal*, the *Michigan Law Review*, the *Southern California Law Review*, the *Vanderbilt Law Review* and the *Duke Law Journal*.

He served as judicial law clerk to Justice Harry A. Blackmun of the U.S. Supreme Court and to Chief Judge Clement F. Haynsworth Jr. of the U.S. Court of Appeals for the 4th Circuit prior to joining the law firm Robinson, Bradshaw & Hinson in Charlotte, N.C., where he later became a partner.

After receiving his bachelor's degree from the University of Wisconsin, Coenen earned his law degree from Cornell University, where he served as editor in chief of the *Cornell Law Review*.

I was drawn to law teaching largely by watching my own law teachers in action. I sensed that I could make a contribution to the growth of students and that I could find meaning in both the human interactions and scholarly work that being a law professor involves. Julian A. Cook III J. Alton Hosch Professor of Law B.A., Duke University M.P.A., Columbia University J.D., University of Virginia



Julian A. Cook III has been named a J. Alton Hosch Professor of Law. Cook joined the Georgia Law faculty in the fall of 2006 as an associate professor and was promoted to the rank of full professor in 2007.

He came to Georgia Law with nearly 10 years of legal teaching experience, most recently at Michigan State University. His other academic appointments were at Widener University, American University and Texas Southern University.

Specializing in criminal law, criminal procedure and evidence, Cook worked for several years as an assistant U.S. attorney in the District of Nevada and the District of Columbia. While a federal prosecutor and a member of the Organized Crime Drug Enforcement Task Force, he was responsible for handling an array of criminal matters, including felony narcotic, white-collar and various arrest-generated cases during the trial and appellate stages. He also served as a judicial clerk for Judge Philip M. Pro of the U.S. District Court for the District of Nevada.

Cook's scholarly writings have appeared in the *Notre Dame Law Review* (twice), the *Yale Journal of International Law*, the *Colorado Law Review*, the *Brigham Young University Law Review* and the *Harvard Journal of Law and Public Policy*. His most recent article is "Crumbs from the Master's Table: The Supreme Court, Pro Se Defendants and the Federal Guilty Plea Process."

He earned his bachelor's degree from Duke University, his Master of Public Administration from Columbia University and his Juris Doctor from the University of Virginia.

Criminal law is exciting, and it is always changing. I find the study of the everpresent tensions between protecting individual liberties and the enforcement of our criminal laws to be fascinating because it often requires the consideration of a multitude of factors that invariably affect individuals and institutions.

Erica J. Hashimoto Associate Professor of Law A.B., Harvard University J.D., Georgetown University

Erica J. Hashimoto joined the Georgia Law faculty in the fall of 2004 as an assistant professor and was recently promoted to the rank of associate professor. She teaches courses in criminal law, evidence, legal profession and sentencing.

Before coming to the University of Georgia, Hashimoto worked for four years as an assistant federal public defender in the Office of the Federal Public Defender in Washington, D.C. In this position, she gained significant trial experience representing clients charged with a variety of federal crimes. Previously, Hashimoto also served as a judicial clerk for Judge David S. Tatel of the U.S. Court of Appeals for the District of Columbia Circuit and for Judge Paul L. Friedman of the U.S. District Court for the District of Columbia.

Her current research focuses on the various issues surrounding the right to counsel in criminal cases, and she has produced such articles as "Defending the Right of Self-Representation: An Empirical Look at the Pro Se Felony Defendant" in the *North Carolina Law Review*, which was recently cited by the U.S. Supreme Court in *Indiana v. Edwards*.

Hashimoto earned her bachelor's degree with honors from Harvard University and her law degree *magna cum laude* from Georgetown University, where she served on the *Georgetown Journal of Legal Ethics* and was inducted into the Order of the Coif.

I decided to study law because someone once told me that in order to achieve change in the world, you occasionally need a good two-by-four, and litigation is that two-by-four. I wanted to learn to wield it.

#### Lori A. Ringhand

Associate Professor of Law B.A., University of Wisconsin at Eau Claire J.D., University of Wisconsin B.C.L., University of Oxford

Lori A. Ringhand has joined the Georgia Law faculty as an associate professor teaching courses in constitutional law, election law, and state and local government.

Previously, Ringhand was an associate professor at the University of Kentucky College of Law. She has also served as a visiting scholar at the Oxford Institute of European and Comparative Law and has worked at the law firm Foley & Lardner in its litigation and regulatory departments.



Ringhand's research focuses on empirical and

normative work regarding the voting patterns and practices of U.S. Supreme Court justices. Her scholarship has been published in journals such as the University of Pennsylvania Journal of Constitutional Law, Constitutional Commentary, the Columbia Journal of Transnational Law and the Oxford Journal of Legal Studies.

Ringhand earned her bachelor's degree from the University of Wisconsin at Eau Claire and graduated *magna cum laude* from the University of Wisconsin Law School, where she was second in her class and served as articles editor of the *Wisconsin Law Review*. She then obtained her Bachelor of Civil Law, with distinction, in European and Comparative Law from the University of Oxford (Jesus College).

Georgia Law is a great school with a strong tradition of producing excellent lawyers. It also has a very wellrespected and nationally known faculty, which I am looking forward to being part of.

Peter B. "Bo" Rutledge Associate Professor of Law B.A., Harvard University M.Litt., University of Aberdeen J.D., University of Chicago

Peter B. "Bo" Rutledge has joined Georgia Law as an associate professor teaching courses in civil procedure, international litigation, international arbitration and international business transactions.

He previously taught at the Catholic University of America where he was selected "Professor of the Year" by law students for four straight years. Before entering the teaching academy, he practiced at

Wilmer Cutler & Pickering and Freshfields Bruckhaus Deringer (in Austria). He also clerked for U.S. Supreme Court Justice Clarence Thomas and Chief Judge J. Harvie Wilkinson III of the U.S. Court of Appeals for the 4th Circuit.

Rutledge co-authored International Civil Litigation in the United States and has written numerous articles appearing in journals such as the University of Chicago Law Review, the Vanderbilt Law Review, the Georgia Law Review and the Journal of International Arbitration. Additionally, in 2008, the Supreme Court appointed Rutledge to brief and argue the case of Irizarry v. United States as amicus curiae. He won the case, joining the ranks of a select few advocates who have successfully defended a judgment below when the government refused to do so.

He earned his bachelor's degree *magna cum laude* from Harvard University, his master's in applied ethics from the University of Aberdeen and his Juris Doctor with high honors from the University of Chicago, where he served as executive editor of the *University of Chicago Law Review* and was inducted into the Order of the Coif.

I chose my area of specialty because I am intrigued by the importance of globalization on the development of the law and the need to produce a generation of lawyers equipped to handle those problems. Hillel Y. Levin Assistant Professor of Law B.A., Yeshiva University J.D., Yale University

Hillel Y. Levin has joined the Georgia Law faculty as an assistant professor teaching courses in civil procedure, constitutional law and legislation.

Levin came to Georgia Law from Stanford Law School where he was an instructor and fellow and taught



legal research and writing. Previously, he served as a judicial clerk for Judge Thomas J. Meskill of the U.S. Court of Appeals for the 2nd Circuit and for Judge Robert N. Chatigny of the U.S. District Court for the District of Connecticut. He also specialized in complex litigation as an associate at the law firm Robinson & Cole.

He concentrates his scholarly research and writing on the empirical and normative evaluation of the legal process and judicial decision making. Recent works include: "Making the Law: Unpublication in the District Courts," "What Do We Really Know About the Revolution in Choice of Law?" and "Is There a Bias Against Education in the Jury Selection Process?" (co-authored with J. Emerson) published in the *Villanova Law Review*, the *Stanford Law Review* and the *Connecticut Law Review*, respectively.

Levin earned his bachelor's degree in history, *summa cum laude*, from Yeshiva University and his Juris Doctor from Yale University, where he served as note and book note editor for the *Yale Journal of Law and the Humanities*.

### visiting faculty

#### Newt L. Gingrich

Carl E. Sanders Political Leadership Scholar B.A. Emory University M.A., Ph.D. Tulane University

Newt Gingrich, former speaker of the U.S. House of Representatives, will serve as a Carl E. Sanders Political Leadership Scholar at Georgia Law in the spring.

Gingrich will lead a course that examines, in the context of the evolution of "judicial review" first enunciated in *Marbury v. Madison*, the U.S. Supreme Court's 50-year-old assertion in *Cooper v. Aaron* that the Supreme Court alone is supreme in the exposition of the law of the Constitution. Through readings and discussion on the Constitution, the Supreme Court's First Amendment jurisprudence and politics, the course will assess whether *Cooper's* expansion of the doctrine of judicial review into a doctrine of judicial supremacy is compatible with the American founders' vision of a constitutional balance among the three branches of the federal government.

A frequent lecturer and author on government ethics and politics, J. Randolph Evans will assist Gingrich with teaching in the spring. Evans is a partner at McKenna Long & Aldridge. He served as counsel to the speakers of the 104th-109th Congresses of the United States. He also participated and supervised matters on behalf of the Office of the Speaker involving separation of powers between the executive, legislative and judicial branches.

Gingrich was first elected to Congress in 1978, where he served the 6th District of Georgia for 20 years. He served as speaker of the U.S. House from 1995 to 1999. In 1995, he was named *TIME* magazine's "Man of the Year."

Today, Gingrich is still involved in shaping public policy. He is a senior fellow at the American Enterprise Institute and a distinguished visiting fellow at the Hoover Institution at Stanford University. He is a member of the Terrorism Task Force for the Council on Foreign Relations and the U.S. Commission on National Security, an advisory board member of the Foundation for the Defense of Democracies and a member of the Defense Policy Board. Gingrich is also an editorial board member of the journal *Biosecurity and Bioterrorism* and a contributor to FOX News Channel.

He writes a weekly newsletter for Human Events. He is the author of 17 books, including the *New York Times* bestseller *Real Change: From the World that Fails to the World that Works*. Gingrich is chairman of the Gingrich Group, founder of the Center for Health Transformation and general chairman of American Solutions for Winning the Future.

#### William B. Chandler III

Visiting Professor of Law B.A., University of Delaware J.D., University of South Carolina LL.M., Yale University

William B. Chandler III has joined Georgia Law for the fall semester of 2008 as a visiting professor teaching Advanced Corporations.

Since 1997, he has served as the chancellor of the Delaware Court of Chancery, a position he was appointed to after serving for eight years as a vice chancellor of the court. From 1985 to 1989, Chandler was a resident judge of the Delaware Superior Court. His legal experience also includes working as an associate at Morris, Nichols, Arsht & Tunnell and as legal counsel to former Delaware Gov. Pierre S. du Pont IV. Additionally, Chandler has taught at a number of law schools, including Vanderbilt University, Washington University in St. Louis, The Ohio State University, the University of Alabama and Widener University.

He is a member of the American Law Institute, the Board of Advisors of the Yale Law School Corporate Law Center, the Third Year Advisory Board of the Washington and Lee University School of Law, the American College of Business Court Judges as well as a trustee of the Weinberg Center for Corporate Governance at the University of Delaware.

### visiting faculty

#### Zanita E. Fenton

Visiting Professor of Law A.B., Princeton University J.D., Harvard University

Zanita E. Fenton will join Georgia Law in the spring of 2009 as a visiting professor teaching courses in the areas of family law and critical race feminism. She currently is a professor at the University of Miami, where she also leads classes in torts, race and the law, and constitutional law.

Fenton served as a faculty member at Wayne State University Law School from 1995 to 2005 and received the Donald H. Gordon Award for Excellence in Teaching in 2000. Previously, she practiced at Cleary, Gottlieb, Steen & Hamilton in New York and served as a judicial clerk for Judge Edward R. Korman of the U.S. District Court for the Eastern District of New York.

Her research interests cover issues of subordination, including those of race, gender and class, in the greater context of understanding violence and the attainment of justice. Among her recent articles are "The Paradox of Hierarchy OR Why We Always Choose the Tools of the Master's House" in the *New York University Review of Law and Social Change* and "Colorblind Must Not Mean Blind to the Realities Facing Black Children" in the *Boston College Third World Law Journal*. Fenton also has a forthcoming chapter on *Town of Castle Rock v. Gonzales* in *Women and the Law Stories* (E. Schneider and S. Wildman, eds.) (Foundation Press).

#### Edward J. Kionka

Visiting Professor of Law B.S., J.D., University of Illinois LL.M., Columbia University

Edward J. Kionka has joined the Georgia Law faculty as a visiting professor for the 2008-09 academic year and will teach courses in the areas of torts and federal courts. For 30 years, Kionka taught at Southern Illinois University where he was a member of the founding faculty and served as associate dean during 1984–85.

Kionka has been a visiting professor at law schools across the country including Washington University in St. Louis, Emory University, the University of San Diego and Saint Louis University. Before his tenure at Southern Illinois, he served as assistant dean and assistant professor at the University of Illinois College of Law and as executive director of the Illinois Institute for Continuing Legal Education. He was also an associate at Leibman, Williams, Bennett, Baird and Minow in Chicago.

Kionka is the co-author of *Evidence: Teaching Materials for an Age of Science and Statutes* and the author of *Torts in a Nutshell* and *Torts Black Letter*. He has written numerous articles appearing in journals such as the *Louisiana Law Review* and the *Illinois Bar Journal*.

#### Frederic F. Manget

Visiting Professor of Law A.B., University of Georgia M.A., University of Oxford J.D., Vanderbilt University

Frederic F. Manget has joined Georgia Law for the 2008 fall semester as a visiting professor teaching Intelligence Law. Manget comes to the University of Georgia after serving 22 years in the Central Intelligence Agency, where he spent most of his career as a legal adviser in the Office of General Counsel.

He joined the CIA in 1986 and was promoted into the Senior Intelligence Service in 1995, where he achieved the rank of SIS-4. In 2002, he received the Attorney General's Distinguished Service Award for support of the prosecutions for the 1998 bombings of the U.S. embassies in Kenya and Tanzania. He has also received the Department of Justice Public Service Award.

Manget has published several articles on intelligence and the law, winning the Studies in Intelligence Award in 1995. Prior to joining the CIA, he was an associate with private law firms in Atlanta. Additionally, he served in the U.S. Army Reserve Judge Advocate General's Corps, retiring after 32 years with the rank of colonel. While in the Reserve, Manget received a Meritorious Service Medal for work done in reorganizing CIA support to the military reserves.

#### Joseph Scott Miller

Visiting Associate Professor of Law B.A., St. John's College M.S., J.D. Northwestern University

Joseph Scott Miller has joined Georgia Law as a visiting associate professor for the 2008–09 academic year. He will teach Patent Law, Intellectual Property Survey, Trademark Law and a seminar on statutory and constitutional interpretation. He comes to Georgia Law from Lewis & Clark Law School, where he has been a faculty member since 2002.

From 2001 to 2002, Miller was a visiting assistant professor at Northwestern University School of Law. Prior to entering academia, he worked as an attorney in the Antitrust Division of the U.S. Department of Justice, where he helped with a variety of investigations that included intellectual property law components. Additionally, he practiced both patent and general appellate law at Sidley & Austin and served as a judicial clerk for Judge Paul R. Michel of the U.S. Court of Appeals for the Federal Circuit.

Miller concentrates his scholarly efforts on intellectual property law issues and examines patent law questions, both alone and within the larger legal structures that govern the competitive process within a market economy. His recent articles include "Remixing Obviousness" in the *Texas Intellectual Property Law Journal* and "Standard Setting, Patents, and Access Lock-In: RAND Licensing and the Theory of the Firm" in the *Indiana Law Review*.

#### Juliet M. Moringiello

Visiting Professor of Law B.S.F.S., Georgetown University J.D., Fordham University LL.M., Temple University

Juliet M. Moringiello will join Georgia Law in the spring of 2009 as a visiting professor, instructing in the areas of bankruptcy and electronic commerce. She will come from Widener University School of Law, where she has been a faculty member since 1993.

Moringiello has also served as a visiting professor at Loyola University at Chicago, the University of Pittsburgh, Pennsylvania State University, the University of Maryland and Université de Paris X. Previously, she worked as an associate at Emmet, Marvin & Martin in New York, where she specialized in real estate and asset-based financing.

A 2006 recipient of Widener University law school's Douglas E. Ray Excellence in Faculty Scholarship Award, Moringiello's research focuses on bankruptcy, commercial law and electronic commerce. Recent publications include "False Categories in Commercial Law: The (Ir)Relevance of (In)Tangibility" in the *Florida State University Law Review* and "Survey of the Law of Cyberspace: Electronic Contracting Cases 2006–2007" in *The Business Lawyer*. She is also a 2007 recipient of the Pennsylvania Bar Association Special Achievement Award for her work in the Uniform Commercial Code enactment process and is an elected member of the American Law Institute.

### visiting faculty

#### Sarah Schindler

Visiting Assistant Professor of Law A.B., J.D., University of Georgia

Sarah Schindler has joined the Georgia Law faculty for the 2008–09 academic year as a visiting assistant professor, leading courses in real estate transactions and animal law. She occupies a one-year teaching fellowship aimed at assisting Georgia Law graduates with the transition into the legal teaching academy.

Previously, Schindler was an associate at Morrison & Foerster in San Francisco where she was a member of the land use and environmental law group. While there, she assisted clients in the development and redevelopment of commercial, residential and mixed-use projects and in the land use aspects of financing real estate acquisitions and developments. She also served as an adjunct substitute for animal law courses at the University of California at Berkeley School of Law and the University of California Hastings College of the Law from 2006 to 2008. Additionally, Schindler served as a judicial clerk for Judge William L. Garwood of the U.S. Court of Appeals for the 5th Circuit.

Schindler contributed to *Animal Law: Cases and Materials* published by the Carolina Academic Press. Presently, she is working on an article concerning recent municipal land use ordinances that require private developers to comply with Leadership in Energy and Environmental Design (LEED) Green Building Standards.

#### **Robert Steinbuch**

Visiting Associate Professor of Law B.A., M.A., University of Pennsylvania J.D., Columbia University

Robert Steinbuch will join Georgia Law for the spring semester of 2009 as a visiting associate professor from the University of Arkansas at Little Rock. While at UGA, he will teach Evidence and Legal Profession.

Before entering academia, Steinbuch spent several years serving the government in various roles as well as working in the private sector.
