## **Conference on Problems in Discovery and Professionalism**

The University of Georgia School of Law will host a one-day conference on Problems in Discovery and Professionalism on Friday, November 15, 2002. The program will start by presenting a picture of the state of discovery in civil litigation in Georgia today through the reported results of a recent empirical survey on the frequency with which Georgia lawyers encounter various types of discovery abuse and their responses to it.

The program is intended for practitioners and judges as well as academics. An outstanding group of experienced judges, litigators, and academics will serve as panelists to consider a series of realistic scenarios in the areas of depositions and document production designed to explore the conduct and choices that give rise to problems in discovery and professionalism.

Nationally renown speakers including Professor Arthur R. Miller of Harvard Law School and Lawrence J. Fox, the former chair of the ABA Section of Litigation, will help examine the causes of discovery abuse and consider whether new discovery rules, more certain sanctions, or different ideas about professional responsibility are needed to curb the incidence of discovery abuse.
