REPORT

Twenty ninth Session of the Seminar on the Law and Institutions of the European Communities held in cooperation with the Institut d' Etudes Européennes of the Université Libre de Bruxelles and the PILC at the Faculty of Law of the Vrije Universiteit Brussel

2 July to 20 July 2001

Introduction

The Brussels Seminar is directed by Professor Gabriel Wilner, Professor of Law, University of Georgia in cooperation with Dean Magits and Professor Dr. Bart De Schutter (Director of PILC), of the Vrije Universiteit Brussel (VUB), Madame R. Kurgan, President of the Institut d'Etudes Européennes (ULB), and Professor Michel Vanden Abeele, Vice President of the Institut and Eric Remacle, Director of the Institut. The Seminar continues to enjoy the support of the University of Georgia Law School. The Seminar also enjoys the support of the Saint Louis University Law School. The facilities of the Institut d'Etudes Européennes (ULB) and the Faculty of Law, Vrije Universiteit Brussel, are made available for the Seminar.

The 2001 session of the Brussels Seminar was supported by the Dean and Virginia Rusk Fellowship fund at the University of Georgia Law School, by the Saint Louis University Law School, by the Commission for Educational Exchange between the United States, Belgium and Luxembourg, by the Commission of the European Communities and by friends and alumni of the Seminar.

The student participants were selected from among law students at U.S. law schools who had demonstrated a significant interest and sufficient background in European law and related areas of law.

At the twenty-ninth session of the Seminar, places were reserved for thirty student participants. Fourteen students from the University of Georgia were given places at the Seminar. Places were reserved for ten students from Saint Louis University Law School. Other law schools in the United States were represented (see list of students annexed to the report). Two participants were from Birzeit University, West Bank.

Faculty

The faculty of the Seminar numbered thirty. Among the criteria for their selection were expertise in the particular subject to be discussed by them at the Seminar, fluency in English and interest in working with United States law students. It was also considered important to include persons primarily engaged in university teaching in EC subject areas, persons whose main activities were within the Commission, Council and Court of the European Communities, and persons who act as practitioners before the Court of Justice of the EC and other decision-making bodies of the EC.

Seminar Sessions

The 2001 Session consisted of 15 working days. Most working days consisted of 6 or 7 hours of lectures or seminars.

The main elements of the Seminar were a series of lectures and discussions, attended by all the participants, held at the Institute of European Studies (U.L.B.) and the Faculty of Law, Vrije Universiteit Brussel. A day was spent at the Court of Justice of the European Communities in Luxembourg where the students attended a hearing and were briefed by Court officials. Eighty hours were devoted to the lectures and discussions.

The history and structure of the EC were the subject of the lectures and discussions given by Professors Youri Devuyt and Tony Joris who also analyzed the Treaty of Amsterdam and the Treaty of Nice. Professor Denis Waelbroeck lectured on the ECJ and judicial protection in the EC. Dr. Taschner, and Professor Wilner took up examples of the harmonization of private law legislation among the members of the Community, including products liability, company law, and the European conventions on jurisdiction and enforcement of judgment and on choice of law in contracts. Mr. Latham lectured on EC consumer protection law.

Professor Bellis and Mr. Spinks gave courses on trade regulation in the EC, while Professor Praet discussed the economic aspects of community trade and monetary policy. Professor Eeckhout spoke on the right of establishment and Professor Michel Waelbroeck gave a course on the Community law on competition and discussed specific problems reflected in policies and judicial decision-making. Professor Joris discussed state aids. Professor Sybesma-Knol lectured on human rights policies in EC. Professor De Schutter spoke on European cooperation in penal legislation. An introduction to EC social law was given by Mr. Currall. Professor Van Thiel gave an introduction to tax law in the EC. Mr. Schloh discussed the EC's Common Agricultural Policy.

Professor Govaere and Mr. Lawrence lectured on the legal aspects of the European Community's external relations. Mr. Lawrence also discussed EC environmental policies. Mr. Van Lier spoke on the building of the single internal market. Mr. Oliver lectured on customs barriers and measures having an equivalent effect. Mr. Van Liedekerke lectured on telecommunications law in the EC. Mr. Benczek surveyed EC intellectual property rules. Ms Schmidt covered approximation in company law. Ms. Beatriz Salvador Garcia covered EC development policies.

Professor Wilner discussed questions relevant to the powers of the Community under international law to make arrangements and undertake other international activities; alternative views of the legal nature of the Community were also the subject of discussions by Professor Wilner with the participants.

Maitre Emil Knops, of the Brussels Bar, gave an introduction to the Belgium legal system as an example of an EC national system. Mr. Stephen Spinks, Mr. David Hull and Mr. Porter Elliot, all alumni of the University of Georgia Law School and of the Brussels Seminar, engaged in a roundtable discussion with the student participants on practice in Europe for U.S. lawyers.

Books and Study Materials

A month before the commencement of the Seminar each participant received by mail a general bibliography of EC law and institutions. Selected bibliographies in specific subjects were prepared by the lecturers. Moreover, outlines of the lectures and relevant EC Court of Justice judgments, decisions of the EC Commission, and Conventions, EC regulations and directives were distributed and used for discussion purposes. Each student received a bound copy of the Treaty of Amsterdam and a bound copy of the Consolidated Text of the European Community Treaty. Moreover, each student received a copy of the book by Mr. Tom Kennedy entitled "Learning European Law" (Kluwer 1999).

Additional Professional Activities

The participants spent a day at the E.C. Court of Justice in Luxembourg where they attended a session of the Court, and received briefings. The participants spent an afternoon at the European Parliament where they received a lecture from Dr. Manuel Medina Ortega, member of the European Parliament (MEP) and a leading member of the Legal Committee of the Parliament. A visit to the Brussels Palace of Justice included further briefings on the Belgian judicial system by Maître Knops.

The student participants and faculty were guests at the 29th annual dinner of the Brussels Seminar. The students participants and certain members of the Faculty were also the guests of the Seminar at a closing lunch and reception.

Students and faculty seminar participants met at receptions at the Institut de Etudes Européennes (ULB). The participants spent one Saturday on a visit to the art cities of Bruges and Damme. The student and faculty participants met with Professor Wilner on several occasions for general discussions of the subjects covered in the Seminar.

Administrative Arrangements

Mrs. C. Charlier of the Secretariat of the Institut d'Etudes Européennes (ULB)(retired) and Mrs. A. Lodens, Administrative Officer at PILC, Vrije Universiteit Brussel were the principal administrators of the Seminar in Brussels. Mr. Frederic Egremont served as assistant to the Director.

Lodgings were provided at the New Continental Flathotel. Students shared double occupancy modern studio apartments with amenities. The New Continental Flathotel is located thirty minutes on foot and fifteen minutes by tram from the Institut d'Etudes Européennes where classes are held. The students were very pleased with the accommodations and upon their urging it has been decided to use the New Continental Flathotel for the 2002 session. The cost of the lodgings were clearly increased by using the flathotel.

Evaluation forms were given to both student participants and the faculty. The views expressed will assist in improving the quality of the Seminar.

Financial Arrangements

Certain observations are appropriate in connection with the financial arrangements for the Seminar. The participants in the Seminar were provided with free lodging at the New Continental Flathotel, but had to provide for other meals. On several occasions either lunch or dinner was provided by the Seminar, and the Institut d'Etudes Européennes..

The 29th Session of the Seminar received substantial financial assistance from grants awarded by the Dean and Virginia Rusk Fellowship Fund at the University of Georgia Law School and Saint Louis University Law School. Contributions were also made by friends and alumni of the Seminar. A financial report is attached to this report.

It is expected that necessary grants will be received for the 30th annual Session of the Seminar. The policy of the Brussels Seminar is that, insofar as possible, the financial situation of students should not be a factor in their participation in the Seminar ; costs to the student participants, have been kept at a minimum. Consequently, in order to carry out this policy, the continuing receipt of grants is necessary. In planning for the 30th Session of the Brussels Seminar, it is also essential to bear in mind fluctuations in the value of the U.S. dollar and the inflation of prices in Belgium; expenses in Belgium must be paid in Euros. In addition, the cost of lodgings for the student participants has increased substantially; participants are lodged at a private flathotel rather than the dormitories at the Vrije Universiteit Brussel (VUB) which has ceased making them available after 26 years of use by the Seminar.

It is expected that there will be special program during the Brussels Seminar to mark its 30th year. The subject of the one day conference will be aspects of the relations between the United States and the European Union. Official of the European Commission and Members of the European Parliament and members of the United States Mission to the EU will be invited to discuss the subject with the student participants in the Seminar. Special funding for the 30th anniversary conference and dinner is currently being sought.
