## MEMORANDUM

To: Rising Second Year Students

As promised, attached you will find a tentative listing of the courses which I expect we will offer in 2006-7, your third year at the Law School. Some caveats are in order:

---Most importantly, understand that this is a plan, not a contract. Things happen in life which cannot be controlled. However, this is what I presently am planning for 2006-7.

--- The attached is a listing of the courses which I intend to be taught by permanent members of the faculty (and in one case a visiting faculty member and in another a hypothetical faculty member who we hope to hire during the upcoming academic year). This list does not include clinical courses and courses taught by adjuncts, visitors, etc. While staffing by adjuncts is necessarily a more contingent situation than staffing by permanent faculty, I am certain we will be offering a full array of courses taught by adjuncts and visitors, including:
