## MEMORANDUM

To: Rising Second Year Students

As promised, attached you will find a tentative listing of the courses which I expect we will offer in 2007-8, your third year at the Law School. Some caveats are in order:

---Most importantly, understand that this is a plan, not a contract. Things happen in life which cannot be controlled. However, this is what I presently am planning for 2007-8.

---- The attached is a listing of the courses which I intend to be taught by permanent members of the faculty. This list does not include clinical courses and courses taught by adjuncts, visitors, etc. While staffing by adjuncts is necessarily a more contingent situation than staffing by permanent faculty, I am fairly certain we will be offering a full array of courses taught by adjuncts and visitors, including:
