**Chad S. Kelly:
Finding the perfect fit**

Before entering law school, Chad S. Kelly (J.D.'02) was – and still is – a Certified Public Accountant. Law was a second career for Kelly, who now manages the Time Warner internal audit function assigned to Turner Broadcasting System. The group undertakes audits, reviews and special projects at all of Turner's divisions, including TNT, TBS, CNN, Turner Classic Movies,

the Cartoon Network, Turner South and the Braves.

"I am in a really dynamic environment," he said. "The media and entertainment industry – a primary driver of our pop culture – is a fascinating business, and I am able to see so many different aspects of this on a daily basis."

Kelly earned both his undergraduate and master's degrees in business, attending UGA and Georgia Southern University, respectively. Following the completion of his degrees in 1992, internationally-renowned accounting firm PricewaterhouseCoopers hired him as a staff accountant in its Savannah, Ga., office.

In 1995, Pricewaterhouse transferred Kelly to Kiev, Ukraine, where he served as a consultant to the Ukrainian government and aided in opening an eastern European branch of the firm that would offer merger and acquisition support, business advisory services and traditional audit services. He hired and trained native Ukrainians to staff the office, quickly honing his proficiency in Russian.

After returning to the United States, Kelly decided to pursue a dream held since childhood: obtaining a J.D. While attending law school, he also taught an introductory accounting class to students at UGA's Terry College of Business.

After earning his law degree, Kelly associated with Powell, Goldstein, Frazer & Murphy in Atlanta, dealing with the financial issues of law such as organizing *de novo* financial institutions and assisting in corporate reorganizations.

However, no longer managing projects that allowed him to travel often or working with people in a teaching capacity, Kelly soon began to miss the cross-border transactional work and client intimacy his accounting career afforded him.

"I like teaching others and passing on what I have learned to see them develop as professionals," he said. "I also enjoy being a change agent – doing something that changes the way a company does business – and my position in the legal field did not allow me to do that on a regular basis."

Luis A. Aguilar: Committed to his community

As a partner with the Atlanta office of McKenna Long & Aldridge, Luis A. Aguilar (J.D.'79) is quite the globetrotter. He has also assisted groups such as the Mexican American Legal Defense and Educational Fund (MALDEF), which employs legal tactics to promote the civil rights of Latinos.

Aguilar's hard work with these organizations has not gone unrecognized. In 2005 alone, he was selected as the Member of the Year by the Georgia Hispanic Chamber of Commerce, named the Latino Attorney of the Year by the Hispanic National Bar Association, included in the 2005-06 edition of *The Best Lawyers in America* and received MALDEF's Excellence in Leadership Award.

Aguilar said his involvement in these organizations provides a platform for analyzing a variety of issues – in particular, the effects that have arisen in business and in our communities from the tremendous growth of the Hispanic community.
