Remembering Emma Terrell

Those of us who knew Emma P. Terrell, whether it was six weeks or 25 years, know the photograph above epitomizes the free, open and friendly spirit that she imparted to everyone who crossed her path. Emma's employment at the law school began in April 1979 and continued through several deans, numerous staff members and thousands of students and alumni. Most of us remember getting to know, working with and having fun with Emma. Her comprehensive involvement in all things law school and her terrific (and sometimes terrifying) anecdotes connected us all.

Emma worked at the law school for more than 25 years. For the last 20, she was a dean's office administrative specialist and served under five different deans. Below are some of their words regarding this special person.

Emma passed away at the age of 58, after suffering from kidney disease for several years. She is survived by her sons Chris and Ryan Terrell, three sisters and three grandchildren.
