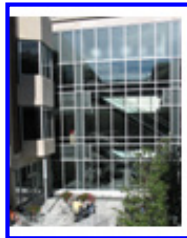

### Renovation complete: Space opens for students/alumni

Just last week, the finishing touches were put on the law school's renovations. These changes, made possible in part by alumni donations, were made to repurpose underutilized areas and to address the overcrowding of public spaces and offices in the law school's primary building. ### Georgia Law once again recognized as a "best value" law school

In a recent ranking, Georgia Law was named fifth best in the nation for providing a quality legal education at an affordable price. The listing of "Best Value Law Schools" was compiled by *preLaw* magazine and appeared in its Fall 2011 edition. Other similar listings published in 2011 have recognized Georgia Law for having a high graduate standard of living (2nd) and for providing the most financial value at graduation (10th). ### Advocacy program off to great start with two national wins

Georgia Law captured the top trophy in this year's National Buffalo-Niagara Mock Trial Competition, which is one of the largest single tournaments in the country. Congratulations to third-year law students William F. Carter, Chadrick A. Mance, Samuel E. Meller and B. Clarke Nash for defeating a field of more than 100 competitors representing 31 law schools from 15 states to finish in the top spot.

Additionally, third-year law students R. Tyler Fisher and Miguel A. Trujillo won the 2nd Annual Mercer University Legal Ethics and Professionalism Moot Court Competition, and Trujillo was named "best oralist" of the championship round. This is the first year Georgia Law has competed in this national tournament, which included 22 teams from 17 law schools.

### Conference to examine international energy security

International energy governance issues, regulatory law in the renewable energy sector, and nuclear safety law and nuclear waste legal regimes post-Fukushima are some of the topics that will be discussed during the *Georgia Journal of International and Comparative Law's* energy security conference Feb. 3. Titled "Striking the Right Balance: Energy Security in International Law," the event will feature a keynote address by Commissioner William C.
