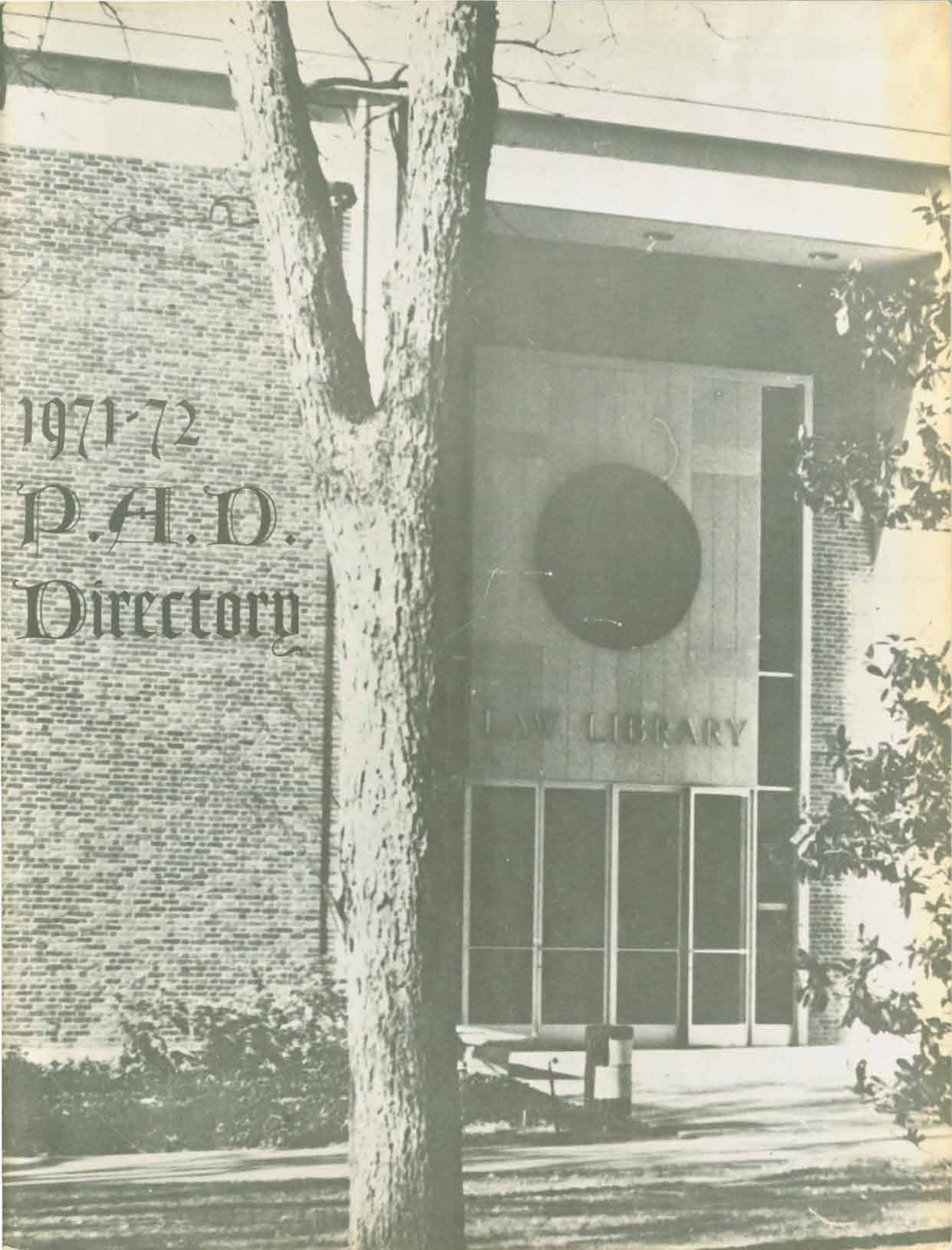

The brothers and associates of Phi Alpha Delta Law Fraternity have prepared this 1971-72 edition of the University of Georgia Law School Directory as part of our continuing program of service to the student, the law school, and the profession. We hope that it will be helpful to you, and that it will contribute to building a feeling of community within the law school.

This Directory is the product of the members of P.A.D., financed by advertising from the local business community, and supplemented by funds gained through the P.A.D. Research Service. The balance of the total amount raised, once the cost of publication is deducted, is put in the form of scholarship awards to local Phi Alpha Delta members. Last year one \$200 scholarship and two \$100 scholarships were awarded by the fraternity to three members selected by our faculty advisor. 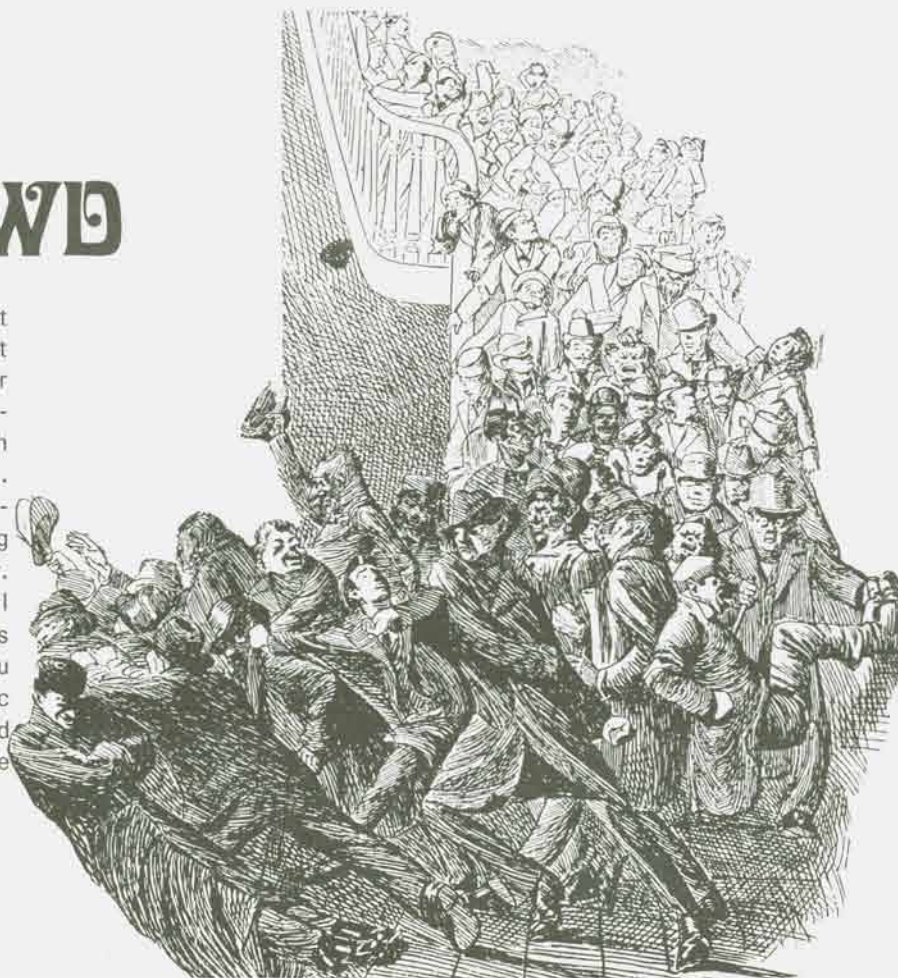
