### Classifications (Law Library)

Call numbers used IN THIS LIBRARY appear on the top left side of the public catalog cards. Do not pay any attention to numbers appearing at the bottom of the cards.

KF	Balcony	L - Z	


### Symbols (Law Library)


Symbols appear on the top left side of public catalog cards. Many symbols will be followed by a call number (eg: TAX/KF6750/A514), and some are alone (eg: Text and Treatises). The symbols are used to hold together the classified or unclassified material belonging to a particular collection.

NOTE: There are some cards in the public catalog whose top left side is blank. They refer to unclassified material which will be generally found in "Text and Treatises".


