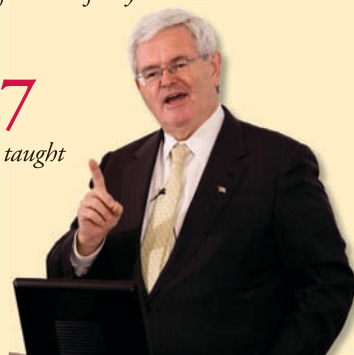


Fourth graduate in five years to 16 serve as U.S. Supreme Court clerk

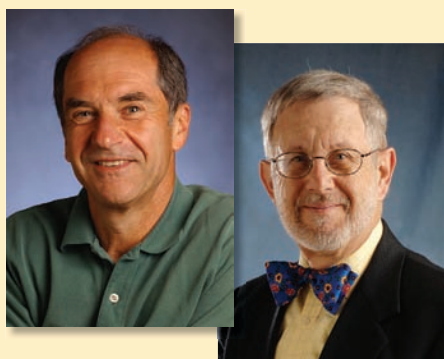
