### Lexis Citator Enhancements

There have been several improvements in the Lexis system regarding access to Shepard's and Auto-Cite. You can now transmit your request for a citating service from any screen you are viewing by typing Shep or AC instead of pressing the Select Serv. key.

#### Westlaw

United States International Trade Commission documents are now available on Westlaw. The database includes: International Trade Commission Investigative Reports from 1979; ITC Administrative Law Judge Recommended Determinations and Orders and ITC "Public" General Counsel Memoranda. To access this material type in the identifier FIT-ITC.

#### Computer Training

Training on both the Westlaw and Lexis systems for second and third year students will begin on Monday, February 11th. A complete schedule will be posted and sign-up sheets for small group instruction will be available at the Circulation Desk. Training for first year students will begin in March.

#### Georgia Texts

The Library Staff has compiled a bibliography of titles which cover specific areas of Georgia law. This list is kept at the Circulation Desk with the Reserve Book lists. The majority of these titles are kept on permanent reserve.

# Federal Procedural Rules

The West Publishing Company publishes two handy, one volume desk books containing the Federal Rules.

- 1. Federal Rules: Civil Procedure, Evidence, Appellate Procedure. This volume contains Rules of Civil Procedure with committee notes, Rules of Evidence, Rules of Appellate Procedure and the text of Title 28, U.S. Code as well as other selected items relevant to civil causes.
- 2. Federal Rules: Criminal Procedure, Evidence, Appellate Procedure. This volume contains the Rules of Criminal Procedure with Committee notes, Rules for Misdemeanors Before United States Magistrates, Rules of Evidence, Rules of Appellate Procedure and the text of Title 18, U.S. Code as well as other selected items relevant to criminal causes.

Both of these volumes are shelved in Reserve under United States.
