Re: Fall Semester Course and Faculty Update

Date: April 13, 2001

The course descriptions appearing in the current Student Handbook, both hard-copy and on line, are basically accurate. I offer the following as updates on credit allocation, course descriptions, etc. for your benefit as you begin the registration process. I also offer brief descriptions of two visiting faculty and several adjunct faculty with whom you may not be familiar.

New Courses, Course Modifications, Etc.

Civil Tax Procedure--(3 credits)----Professor C. Watson--This course will be a modified version of the previous Tax Practice and Procedure course which covered both civil and criminal matters. Examines the structure of the IRS, and the administration and enforcement of the Internal Revenue Code, including taxpayer requests for rulings, closing agreements, offers in compromise, preparation and filing of returns, audit procedures, administrative appeals, deficiencies, assessments, jeopardy and termination assessments, penalties, interest and statute of limitations, as well as jurisdictional and procedural problems and considerations arising in the litigation of federal tax cases before the U.S. Tax Court, District Court and the Court of Federal Claims. Also considered are civil collection, levy and distraint, and the tax lien and its priorities.

Complex Litigation--(3 credits)----Visiting Professor Cound--This course will be taught as a 3-credit course, rather than the 2-credit course described in the Student Handbook.

Corporate Finance--(2 credits)--Professor Johnson--This course will be a totally revamped version of the 3-credit course which was taught in Spring Semester of 2001. A traditional law school text will be used and the course will focus on valuation decisions and directors' duties as articulated in case law. The course will begin with a simplified discussion of how to value the corporate entity and proceed to the choice of financing through debt, equity and other hybrid securities. Problems of capital structure and the duties of directors to various classes of claimants will be examined using decisions about dividend policy and dissidents' appraisal rights. Control of agency problems through specific contractual provisions will be examined using debt covenants and employment contracts. Prior completion of, or concurrent enrollment in, Corporations is required. (The course taught in Spring Semester 2001 may be offered in the future as "Finance Theory in Legal Practice.")

International Law/International Relations (3 credits)--Professor Schoenbaum--Provides the basic framework for understanding the international legal system and the role of law in international affairs. General topics will include: 1) the history and background of international law; 2) the relationship between international law and international relations; 3) the sources of international law; 4) international legal participants; 5) international dispute prevention and settlement; 6) the relationship between international and domestic law; 7) state jurisdiction and immunities; 8) state responsibility; and 9) territory. After this background, selected specific topics will be considered, such as the use of force, human rights, international environmental law, and international economic law.

Land Use Planning--- (3 credits)--Mr. Ellis---This course will be taught as a 3-credit course, not the 2-credit course which was taught last fall.

Real Estate Transactions --(2 credits)--Professor Smith--This course will be taught as a 2-credit course, not the 3-credit course which has been taught in the past

State and Local Taxation--(3 credits)--Professor Hellerstein---This course will be taught as a 3-credit course, not the 2-credit course indicated in the Student Handbook.

Visiting Faculty, Fall 2001

Charles W. Ehrhardt --Professor Ehrhardt is the Mason Ladd Professor of Evidence at Florida State University College of Law. Having earned his J.D. at the University of Iowa, he clerked for Judge M.D. Oosterhout of the U.S. Court of Appeals for the Eighth Circuit. He joined the FSU College of Law faculty in 1967 and was named Mason Ladd Professor of Evidence in 1977. He was named the Outstanding Professor of the Year four terms during his service at FSU. Professor Ehrhardt serves as chair of the FSU Athletic Board. He is a Commissioner to the National Conference of Commissioners on Uniform State Laws and also serves on the faculties of both the National Judicial College and the Federal Judicial Center. Professor Ehrhardt will teach Evidence and a section of Trial Practice this fall.

John J. Cound---Professor Cound is Professor Emeritus at the University of Minnesota Law School and is a nationally-recognized expert in civil procedure. He received his B.A. degree from George Washington University and an LL.B. degree from Harvard, where he graduated, magna cum laude, and was Note Editor of the Harvard Law Review. He clerked for Judge Learned Hand on the United States Court of Appeals for the Second Circuit. He then served as an attorney for the Appellate Section of the Civil Division of the Department of Justice. He joined the faculty of the University of Minnesota Law School in 1956 and has been a visiting professor at UCLA, the University of North Carolina, University of Texas, University of Kentucky, Washington University School of Law and the Christian Albrechts Universität in Kiel, Germany. He also has served on the faculty of the Association of American Law Schools Orientation Program in American Law. He coauthored a leading casebook on civil procedure and served as a Reporter for the Minnesota Criminal Jury Instruction Guides from 1971 to 1977. He will teach Civil Procedure and Complex Litigation this fall.

Adjunct Professors, Fall 2001

Howard Abrams will teach the course in Regulation of Non-Profit Organizations. Mr. Abrams is a Professor of Law at Emory University. A Harvard Law School graduate (1980), he has served on the faculty at the University of Oklahoma and was a Visiting Professor at Cornell and at Leiden University in Holland. He has written several books in the field of taxation and has taught this course and others during the past decade at the Law School.

Mr. Victor Ellis will teach Land Use Planning this fall as he did last fall. He is an attorney with Seyfarth, Shaw in Atlanta, with a practice primarily devoted to litigation, zoning and land use. He earned his undergraduate and graduate degree at the University of Arizona and his J.D. at Southern Methodist Law School. He was on the editorial board of the SMU Law Review and taught German as a teaching assistant while in graduate school. He worked as an attorney for two years at Pursley, Howell, Lowery & Meeks and McCullough, Glass & Sherrill before joining his present firm.

Ms. Laurie Fowler will be teaching the Environmental Law Practicum as she has for many years at the Law School. She is a 1983 graduate of the Law School and has served as Director of the Georgia Environmental Policy Institute, which provides legal and technical assistance to state and local governments in the area of pollution prevention. She also has a teaching appointment in the University's Institute of Ecology.

Mr. Steve Harper will teach a section of Trial Practice. He is Assistant Director of the Institute for Continuing Legal Education in Athens. He is a graduate of the United States Military Academy and the University of Alabama Law School. He previously taught at West Point and was the Staff Judge Advocate at Fort Gordon. He tried cases and served as a trial judge while in the Judge Advocate General's Corps.

Mr. Ken Mauldin will teach a section of Trial Practice. He is a 1980 graduate of the Law School and served as Solicitor of the State Court of Clarke County until he resigned to run for District Attorney for the Western Circuit, to which position he was elected in the fall of 2000. He earned his LL.M. in 1989 from Emory Law School and has taught trial practice here at the Law School for many years.
