# The Brussels Seminar

## AIM OF THE SEMINAR

The principal aim of the Brussels Seminar is to provide a group of interested American law students with intensive exposure to the law and institutions of the European Community within the new European Union. The process of completion of an integrated internal market, the remarkable expansion of the scope of the Community as evidenced by the Treaty on European Union which envisages an economic and monetary union and a political union, the accession of the new members of the EU and the further expansion of the Union, the fundamental changes in the political and economic systems in Central and Eastern Europe and the Community's reaction to them, and the challenges of the GATT-94, will be the subject of particular attention in Seminar discussions. The participants in the Brussels Seminar will explore and discuss both general and specific aspects of the economic, social and legal integration being sought through the Community. The impact of European political and economic integration on relations with the United States will also be reflected in Seminar discussions.

## DEDICATION

The twenty-fourth session of the Brussels Seminar is dedicated to the memory of Professor Dean Rusk, Secretary of State of the United States from 1961 to 1969 and thereafter Samuel H. Sibley Professor of International Law at the University of Georgia School of Law. He played a key role in the establishment of the Brussels Seminar and honored the Seminar with his active support for twenty-three years thereafter.

## BACKGROUND NOTE

The Brussels Seminar has been directed by Professor Gabriel M. Wilner since its inception in 1973. It is conducted in cooperation with Professor André Sapir, President of the Institute of European Studies, Université Libre de Bruxelles (ULB) and Professor Bart De Schutter, Director of the Program in International Legal Cooperation of the Vrije Universiteit Brussel (VUB).

The twenty-fourth session of the Brussels Seminar will receive its principal financial sponsorship from the **Dean and Virginia Rusk Fellowship Fund at the University of Georgia Law School** and from **The School of Law, Saint Louis University**.

Further support will be extended by the Commission and the Court of Justice of the European Communities, by the Commission for Educational Exchange between the United States, Belgium and Luxembourg, and by friends and alumni of the Seminar.

The Brussels Seminar will take place from 3 to 20, July, 1996. Thirty-five qualified student participants will be selected principally from among United States law students. Students who have finished one year of legal training can be admitted on the basis of previous work in areas of relevance to EC law. Some preference will be given to students who have completed two or more years of legal training. Students entering into their third year of law study are encouraged to attend the second period of the Hague Academy of International Law on Public International Law upon completion of the Brussels Seminar.

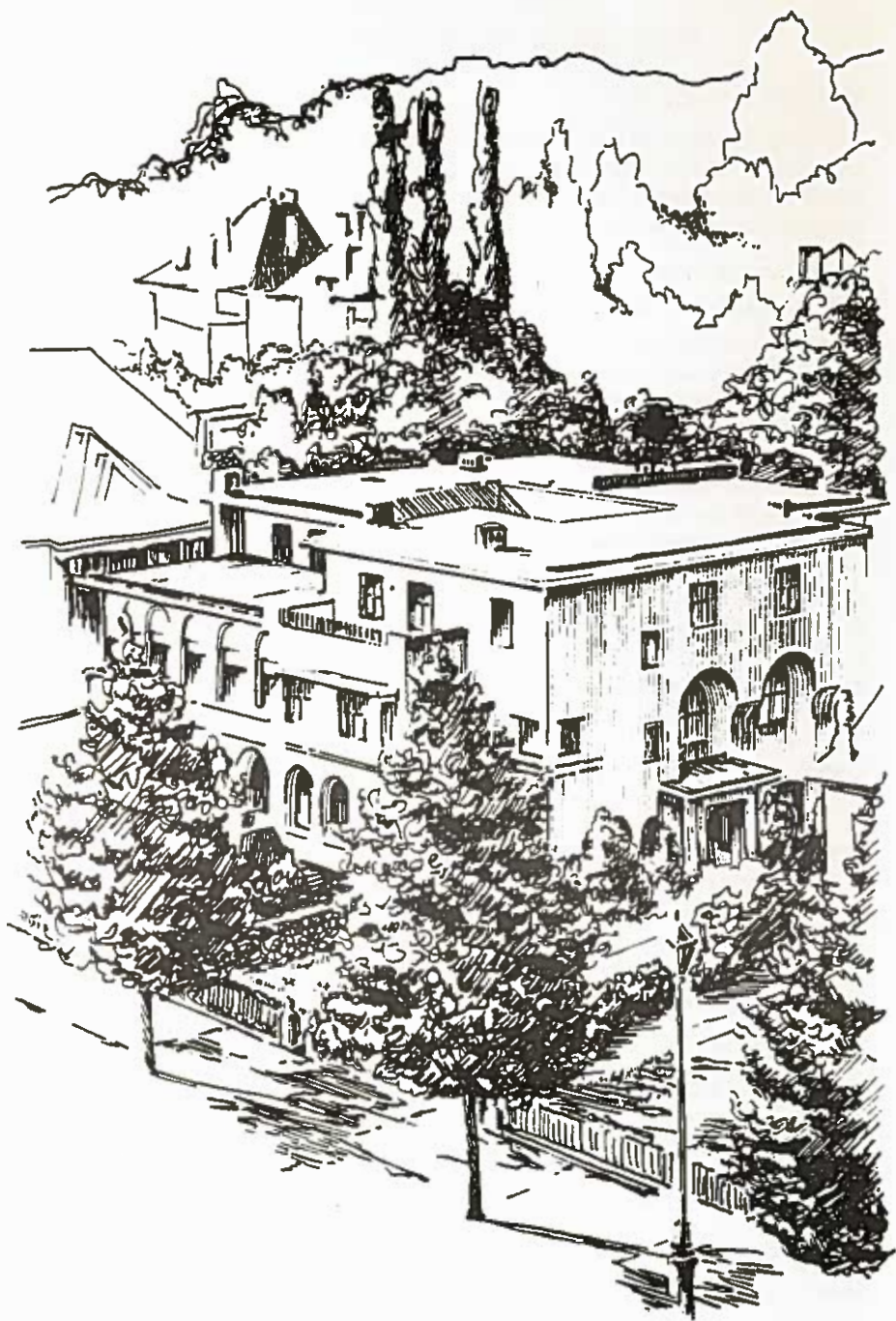

### Arrangements Regarding Tuition and Accommodations

The Seminar will meet the costs of tuition (including study materials) and lodgings of student participants for the period of the Seminar. The participants will also be guests of the Seminar for the excursions to Bruges and Luxembourg, and at receptions, luncheons, and the annual dinner organized for the Seminar. Facilities for meals will be available at the Universities at a greatly reduced price. Each student must pay the **registration fee of \$680\*** upon arrival at the Seminar. Each participant will be expected to provide his or her own transportation from the United States to Brussels and return. The Seminar will not pay any expenses for spouses or others accompanying participants.

\*Students from the sponsoring institutions will benefit from an adjustment in the registration fee.
