Re: Late Registration/Schedule Adjustment
Date: August 10, 2004

As we begin the next phase of Fall Semester registration, I write to provide some updates about the Fall Schedule. For various reasons, there have been a fair number of changes in the schedule (mostly the addition of new courses) since the schedule under which the first stage of registration took place last spring. In addition to the information provided here, additional information about courses and faculty are provided in [my memorandum of April 17, 2004 on Registration for Fall, 2004](#), which is available on the web on the Law School Registrar's page.

Antiterrorism & Criminal Enforcement Seminar—This two-credit seminar will be offered by Visiting Professor Larry Thompson on Tuesdays from 10:30-12:20 in Room E. The topics to be selected for this seminar course will include the interplay between domestic law enforcement and national security issues as they relate to anti-terrorism. The seminar will cover case law, executive initiatives, and legislation involving anti-terrorism. Those who took Professor Thompson's anti-terrorism course last spring **are** eligible to take this seminar. While there are no pre-requisites, a prior course in criminal procedure would be helpful. Biographical information on the instructor is available on the Law School web page.

Arbitration Seminar—This two-credit seminar will be taught by Dean and Professor Emeritus J. Ralph Beard on Wednesdays from 3:30 to 5:20 p.m. Biographical information on the instructor is available on the Law School web page.

Economic Analysis of Law—This two-credit course, which is normally taught in the spring semester, will be taught this year in the fall. It will meet on Friday from 10:30-12:20 in Room I. It will be taught by Professor Jeff Netter of the Terry College of Business.

Health Care Financing—This three-credit course will be taught by Mr. William Boling from 5:30-6:45 p.m. on Mondays and Wednesdays. Mr. Boling is General Counsel to the MCG Health System in Augusta, where he has worked since 2001 and where he directs the activities of the Risk Management and Compliance departments. For 18 years prior to that he was in private practice in Rome, Georgia. He earned his J.D. from the Law School in 1981. He has served as an adjunct professor at Georgia State College of Law and been active in the fields of mediation and arbitration.

Land Use Clinic—The classroom component for this clinic, taught by Ms. Jamie Baker-Roskie, will meet at 9:30-11:20 on Friday in Room D. Biographical information on the instructor is available on the Law School web page.

Law and Politics-----This two-credit course will focus on the relationship and interaction between "The Power of Politics and the Rules of Conduct Prescribed by the Law." The instructor will be Mr. George T. Smith and the class will meet at 3:30-5:20 p.m. on Thursdays in Room E. Topics will include local politics and the law, state politics and the law, the (internal and external) politics of the appellate courts, reapportionment and redistricting and legal education's role in training for life in the profession and practice of the law. This course will be graded on a **pass/fail basis and will be limited to 3rd year students**. Enrollment will be limited to 20 students. Biographical information on the instructor is available on the Law School web page.

Partnership Tax—Because of Professor Larry Blount’s death last spring, this course will not be taught this fall. We are attempting to arrange for it to be taught this coming spring semester. For those interested, we already have made arrangements for the Corporate Tax course to be taught in the spring.

Patent Law—This will be taught as a three-credit course for the first time. The course will meet on Tuesday, Wednesday and Friday from 11:30 to 12:20 in Room K. The instructor will be Visiting Professor Kelly A. Casey, of the Law School’s Class of 1998. She earned her degree *summa cum laude*, was elected to the Order of the Coif and was the First Honor Graduate in her class. Since graduation, she has clerked in the U.S. Court of Appeals for the Eleventh Circuit and in the United States Court of Appeals for the Federal Circuit. For the past three years she has been in the private practice of law, specializing in intellectual property issues, primarily in an appellate practice.

Pre-Trial Civil Litigation—This course (which now bears a new title instead of “Drafting of Pre-Trial Litigation Documents” as it appears in the Student Handbook) will be taught at 2:30-4:20 on Tuesday by Mr. Gary Gerrard. In this 2-credit course, the student will play the role of a lawyer in a civil law firm assigned cases for which he or she is primarily responsible. Beginning with the decision to whether accept representation of a particular client, the course will cover each of the major steps necessary to get a civil case ready to start trial. There are no pre-requisites for this course, but Evidence and Legal Profession are suggested as helpful courses to have completed. **The course enrollment will be limited to 12 students and only third-year students are eligible.** Biographical information on the instructor is available on the Law School web page.

Minicourses for the Fall Semester

Introduction to European Competition Law—As part of the Law School’s exchange program with the law school of University Jean Moulin Lyon 3 in France, Professor Mathieu Cardon will offer this one-credit course. The course will focus on the application of the provisions of Art. 81 (dealing with cartels) and of Art. 82 (dealing with abuse of dominant position) of the European Community Treaty and certain some aspects of EC Merger Law. Specific topics which will be considered include: extraterritorial application of competition law, effects doctrine, international cartels, leniency policy, relevant market concept, champion theory, bilateral agreements on the application of competition law (and the two generations of cooperation agreements) and international competition law. Contrasts with American antitrust law will be drawn, focusing on competition cases involving international or transnational disputes, such as the Vitamins Cartel case, the European Microsoft Case, the Boeing Mc Donnell Douglas merger, the GE/Honeywell merger. Professor Cardon is a graduate of the University of Lyon Law School, where he serves as an Associate Professor. His specialties include Antitrust Law, Public International Law, International Trade Law and Administrative Institutions. He has taught in the LSU summer program in Lyon and has been a research scholar at Boston University Law School.

International Legal Research—This 1-credit course provides an overview of international law, with an emphasis on the resources and skills used to locate relevant international and foreign resources. Although students and researchers of international and comparative law should find this course particularly useful, non-specialists will also find it helpful in an increasingly global arena.

The course will be taught by Ms. Anne Burnett, Foreign and International Law and Reference Librarian at the Law School, and Dean Gabriel Wilner. Ms. Burnett is 1990 *cum laude* graduate of the Law School and served as Editor in Chief of the *Georgia Journal of International and Comparative Law*. She earned her Masters in Library Science from the University of Texas in 1994 and came to the Law Library after serving on the staff of the Young Law Library of the University of Arkansas School of Law.

The course will meet on Thursdays from 3:30-5:20 p.m. in Room I beginning on September 2 and concluding on October 14.
