Date: December 3, 2002

The following minicourses have been added to the spring schedule and are available for registration. Each of these minicourses carries one academic credit. The point allocation system will not apply to these minicourses. I expect there may be one more minicourse made available. If so, it will be announced sometime in the next week or so. Please note that each course description contains the JURI number and the call number for each minicourse.

Economic and Social Human Rights Since the Fall of the Berlin Wall—The course will address issues of human rights and economic development in their contemporary context. Has the current form of globalization failed to live up to the high expectations as formulated in the Universal Charter of Human Rights, the International Covenant on Economic, Social and Cultural Rights and other such international and regional instruments? International organizations set up to safeguard and implement these rights seem powerless to fulfill their mission. The International Labor Organization, the United Nations Conference on Trade and Development and others have given way to the forces of a one-sided form of globalization. The United Nations High Commission for Refugees is a lone voice of opposition. The course will cover, among other issues: the hijacking of the General Agreements on Trade in Services to impose investment disciplines, the effectiveness of legal rights in international economic organizations, the limited development objectives of current international organizations and the failure of the WTO to live up to its limited objective. Professor Kim Van der Borgh is a member of the law faculty of Hull University (England) and teaches and writes extensively about the intersection of human rights and economic and social policies in the international community. He is completing a Ph.D. degree on aspects of the world trading system in the WTO. He has taught at the Law School several times in the past.

International Law of Human Rights—The course will examine the current international law of human rights. Most of the classes will be devoted to coverage of the United Nations system of human rights, the declarations, the various human rights treaties, the work of the U.N. Human Rights Center in Geneva and the Human Rights Committee. There also will be some discussion of the regional systems, in particular the European and Latin American conventions and courts of human rights. JURI 5380; CALL NUMBER 49398

Professor Togesh Tyagi is a professor of law at J. Nehru University in New Delhi, India. He has given this minicourse several times at the Law School.

International Sales Law: the 1980 Vienna Sales Convention--This course focuses on the 1980 Vienna Sales Convention, a convention which is in force in more than 60 States and governs more than 2/3 of world trade. The course deals with the Convention's most relevant

provisions, such as the ones governing the Convention's sphere of application, its rules of non-conformity of goods and interest. JURI 5390; CALL NUMBER 29402

Professor Franco Ferrari earned his J.D. (with honors) from Bologna University, Italy, and an LL.M. degree from Augsburg University, Germany. He then began teaching as a visiting professor at various European and US law schools until 1995, when he became full professor of comparative law at Tilburg University, Netherlands. In 1998, Prof. Ferrari accepted a full professorship from his alma mater. From August 2000 to April 2001, Prof. Ferrari was Legal Officer at the United Nations Office of Legal Affairs, International Trade Law Branch. Currently Prof. Ferrari is full professor of international law at Verona University, School of Law. He has taught at the Law School several times before.

Medical Malpractice— A nuts and bolts approach to medical malpractice law and litigation in Georgia. Taught by practicing attorneys, plaintiff and defense perspectives are offered. While the focus is on substantive law, the procedural aspects of such cases are also covered. JURI 5590; CALL NUMBER 69404

Jay Cook is a member of the Athens law firm of Cook, Noell, Tolley & Wiggins. A 1964 graduate of the Law School, he has offered the medical malpractice seminar for many years. He is active in the American Association of Trial Lawyers and a former president of the Athens-Western Circuit Bar Association. Weymon Forrester is a partner in the Gainesville, Ga. firm of Forrester & Brim. He earned his undergraduate and law degrees at Emory University and is a former president of the Gainesville-- Northeastern Bar Association and vice president of the Georgia Defense Lawyers Association

The course will meet 5:30-7:20 p.m. in Room G from February 19 through April 9.

The United Nations System---After a general presentation of the structure of the United Nations system (U.N. specialized agencies and other entities linked to the system) the class will focus on the work of the Security Council : its procedures, powers and functions, and how the distinction between peace enforcement and peace-keeping has turned into greater flexibility since 1990. The class will also examine the limits to Security Council actions, both legally under the U.N. Charter and as a matter of policy and politics. In that context, the class will study several crises and the Security Council's actions on peace building, maintenance of peace (preventive diplomacy), restoring peace and enforcing peace. Professor Jean-Yves de Cara is Professor of Law and Director of the Center of International and European Law, Universite Jean Moulin (Lyon 3), Lyon France. He is an avocat and barrister (in England) and lectures extensively in Europe. He has recently been lecturing at the Saint Joseph Law Faculty, Beyrouth. Professor de Cara has given short courses at the Law School on several occasions in the past.
