



Joyce Fleming: Recognized by her peers

Joycelyn "Joyce" L. Fleming (J.D.'78) is one of only eight Georgia attorneys recognized for work in the immigration law arena by the 2005-2006

The Best Lawyers in America, a national referral guide for lawyers.

Only two of those eight are women, and that has a special significance for Fleming, who said females made up only a small percentage of her law class. "It's a great honor, especially because there are not many women listed [in *The Best Lawyers in America*]," she said.

She was selected for *The Best Lawyers in America* based on evaluations by fellow lawyers. She was also recognized as one of *Atlanta Magazine's* "2004 Super Lawyers."

Fleming, who is a partner in the Atlanta office of Ford & Harrison, works in the highly specialized area of business immigration law and also concentrates on health care industry immigration. She manages the firm's immigration law group, which handles cases for 14 Ford & Harrison offices nationwide.

"My specialty has given me a lot of opportunities," she said. "There are so few people who do this."

Fleming advises companies that want to hire or transfer foreign employees and helps foreign employees gain temporary work visas or permanent resident status, among other things.

Immigration is regulated by the Department of Labor and the Department of Homeland Security, both of which are "very bureaucratic," she said. "[Business immigration law] is highly technical and highly regulatory, but behind every file is a person who needs help."

Fleming, who is fluent in Spanish and of Mexican descent, started working in immigration law more than 20 years ago. Soon after graduating from Georgia Law, she took a court-appointed immigration case, which she won. This experience led to her decision to specialize in the area.

"It has suited me very well," she said. "I am a problem fixer. By the time someone comes to me, they have a big problem that needs to be solved."

**William Boling: Capturing everyday objects**

Long before studying law, William H. Boling Jr. (J.D.'81), general counsel for MCG Health System, had a passion for art.

Boling, who also teaches a course in healthcare financing and bioethics at Georgia Law, studied drawing and painting at Georgia State University and L'Ecole Des Beaux Arts in Rennes, France.

Recently, he had a series of his photographs on display at a Greenville, S.C., art gallery. The exhibition was drawn from an extended body of his documentary work that explores everyday

artifacts in the vernacular landscape.

While only 35 photographs were part of the exhibit, titled *Pylon a Typology by William Boling*, the entire collection is comprised of several hundred pictures of traffic cones – yes, traffic cones – from Brazil, Paris, Los Angeles and other places around the world.

In photographing traffic cones and other objects such as abandoned shopping carts and concrete yard statues, Boling said he is playing “tongue, very much, in cheek” with some of the themes examined by pop art and surrealism, a literary and artistic movement that tries to show the workings of the subconscious through imagery.

“The challenge for a lot of postmodern art has been to find subject matter that resonates with an audience and a society that has been very drenched and saturated in images, picture-making and voices through the mass media,” he said.

Through his images, Boling tries to get his audience to think about the “every day mundane things” in the world. “[A traffic cone] is ubiquitous and beneath our radar, yet it is somewhat a sign of our fast-paced, cautionary times,” he said.

One of Boling's other photographic collections, recently published in his book *Photographs from O'Connor Country*, includes images of places in Milledgeville, Ga., and will be on display in June at the Tannery Row Gallery in Buford, Ga. The pictures are Boling's attempt to examine how places in Milledgeville affected Southern novelist and short-story writer Flannery O'Connor, who is known for her works *Wise Blood* and *A Good Man is Hard to Find*.

Rao Rampilla: A new life in the Big Apple

Since graduating from Georgia Law, Rao N. Rampilla (LL.M.'87) has been an international lawyer, a special counsel with the Indonesian

Mission to the United Nations and has worked on numerous civil rights cases.

But after the events of September 11, Rampilla, who was an actor and poet in his native country of India, returned to his artistic roots.

Due to the collapse of the World Trade Center, his work with fellow Law Dawg Li Yang (LL.M.'93), whose office was located in Tower One, ceased.

Shortly thereafter, he obtained an acting role in a Visa commercial. However, Rampilla, who immigrated to America in 1983, did not realize how special this commercial was until it aired during one of the most prestigious primetime commercial slots – the Super Bowl.

Since then, Rampilla – known as R.N. Rao in the acting world – has had roles in *Six Feet in Seven Minutes*, *Sex & the City*, *Uptown Girls*, a play and several commercials and TV shows.

To help perfect his acting skills, he is attending The Juilliard School and The Lee Strasberg Theatre Institute.

He has also taken numerous speech classes to help minimize his strong Indian accent, but he said he sees his accent and ethnicity as an asset.

"I try to be someone else, and it does not work," he said. "So I give them who I am – my accent and my ethnicity.

"I realized acting is what is working for me, and I feel good. ... I am still transitioning, but I am happy being an actor."

He said acting, more than anything else, has helped him to discover who he really is.

"Actors study human character and, in the process, they learn about themselves," he said.

"That is one of the contributions of acting to me. I have yet to see what my contribution to acting will be."
