**Minicourses**  
**Fall Semester, 2002**

Each of the following courses is a one-credit course. There may well be more such courses added to the fall schedule later in the spring or during the summer. Students are advised to check back on the schedule and on this memorandum which will be amended accordingly.

**World Trade Organization and Human Rights--Professor Van der Borght---**

The relationship between international trade and human rights has given rise to much debate. Is it a relationship of irreconcilable differences or is harmonious development possible? This course will focus specifically on the WTO. Issues that will be discussed include constitutionalization, the linkage debate and conditionality. Human rights directly influenced by the WTO include enjoyment of fundamental aspects of the right to life, freedom from cruel, inhuman or degrading treatment, freedom from servitude, the right to equality and non-discrimination, the right to an adequate standard of living, the right to maintain a high standard of physical and mental health, the right to work under just and fair conditions of labor, freedom of association and assembly and the right to collective bargaining, right to education and the right to development.

Kim Van der Borght is a Lecturer at the University of Hull in England. He is a Fellow at the Centre for International Law at the Vrije Universiteit Brussels, Belgium and is on the Roster of Panelists of the World Trade Organization, Switzerland.

**International Law & Preservation of Cultural Heritage--Professor Kowalski-** This course will discuss restitution of works of art pursuant to private and public international law. Evolution of the concept of restitution of art treasures as a legal institution. Allied Restitution Law and recent international treaties, negotiations, cases and other actions aimed at the final liquidation of effects of World War II in field of cultural heritage. Restitution of art objects stolen in time of peace. Difficulties at national level and efforts towards harmonization. 1995 UNIDROIT Convention. Private international law aspects of the restitution in question.

Professor Wojciech W. Kowalski is head of the Department of Intellectual and Cultural Property Laws at the University of Silesia, Poland. He has numerous publications on cultural heritage law, both in Poland and abroad. He has taught at various European universities, courses at the Hague Academy of International Law in 2001. He has served as ambassador ad personam in the

Ministry of Foreign Affairs, responsible for negotiations on the restitution of works of art lost during World War II. He chairs the UNESCO expert group in this field. Member of the Bar. Consultant to museums, media and private firms.
