Georgia Law professor Randy Beck has been appointed the first holder of the Justice Thomas O. Marshall Chair of Constitutional Law. This chair was established by Angie Fitts Marshall in honor of her late husband,

Thomas O. Marshall Jr. (LL.B.'48). Marshall had a long and distinguished legal career that included service as a judge for the Superior Courts of Georgia Southwestern Circuit, the Court of Appeals of Georgia and the Supreme Court of Georgia, where he was chief justice from 1986 to 1989.
