Murphy is the associate deputy attorney general overseeing the U.S. Marshals Office, the Bureau of Prisons and the Parole Commission. "It's a management type job," he said, "dealing with the issues of managing the various agencies and the policies that affect them."

Murphy said there were a number of reasons why he was eager to take the job at the Department of Justice. "I saw it as an opportunity to serve my country and to work for a president and attorney general that I have great admiration for. I also saw it as an opportunity to reunite with Deputy Attorney General Larry Thompson, whom I had worked with at King & Spalding."

After being invited to join the Justice Department by Thompson, Murphy interviewed at the White House and with the attorney general the Thursday before the Sept. 11 attacks on America. Following the attacks, his wife asked him if he really wanted to take the job in Washington. "I told her that if I didn't, then the terrorists have already won because they will have succeeded in altering our lives," Murphy said.

The future remains open for Murphy. He plans on returning to Georgia once his Justice Department job ends. Although he isn't sure what his career plans will be at that point, he says he misses handling cases like he did as a prosecutor and while working in private practice.

Kerry Harike Joedecke - Celebration of a Life

On Sunday, June 30, 2002, the School of Law lost one of its beloved alumni, Kerry Harike Joedecke (J.D.'97). She lost her battle with leukemia just a few days before her 30th birthday.

Joedecke began her law career serving as a clerk to Judge Lamar W. Davis Jr. of the U.S. Bankruptcy Court Southern District of Georgia before becoming an associate at the Atlanta office of the Rogers & Hardin law firm. She remained active with the law school following her graduation, serving on the Law School Association's Younger Law Alumni Committee from 2000 to 2001 and the Board of Visitors from 1997 to 1999. She even married a law school alumnus, Jim Joedecke (J.D.'96).

While studying law, Joedecke was a dedicated member of the Moot Court Team. In 1997, she and two other classmates, Chandler Mason (J.D.'97) and Tom Mew (J.D.'97), won the 47th Annual National Moot Court Competition held in New York City, NY, beating out teams from 160 other law schools. The National Moot Court Competition is the oldest and most prestigious moot court tournament in the country, sponsored by the Association of the Bar of New York.

"When Kerry was first diagnosed with acute lymphocytic leukemia (ALL) and throughout the course of her struggle, the love and support we received from the law school community and the legal community generally was truly incredible. I am glad the award is being established at the law school. It is one small way to ensure that Kerry's courage as a student, lawyer, wife and leukemia patient are not forgotten," he said.
