Georgia Law continues to be recognized for its excellence

The annual *U.S. News & World Report* rankings were released earlier today, and we are proud to report that they reflect the University of Georgia School of Law's commitment to ensuring our students are receiving the best possible return on investment in their legal education. Our overall ranking at 30th is up three places from last year's report and, more importantly, our employed-at-10-months score places us among the top 25 law schools nationally.

Your law school is consistently being recognized for excellence. In January, *The New York Times* highlighted a report released by finance company SoFi that listed Georgia Law as among the top five schools with the best salary-to-debt ratios after graduation.
