of Law has been named the Best Value in Legal Education in the United States by the National Jurist. As these rankings are based largely upon outcome-driven factors such as average indebtedness, bar passage and employment, this speaks volumes to the school's relentless pursuit of a vision to be the nation's very best return on investment in legal education.

Over the past five years, buoyed by your support and holding the line on tuition, the law school has reduced the aggregate annual indebtedness of our students by over \$5 million and for the 2018–19 academic year, almost 40% of our J.D. student body did not borrow funds to support their legal education. At the same time, the first-rate training received here has helped them secure jobs, enabling the school to post one of the nation's top employment rates and an ultimate bar pass rate nearing 95%. This allows our graduates to make their professional choices based on their passions, not their finances, as they embark on their chosen careers.
