

## Getting behind what we truly believe in



*A letter to alumni from the Law School Association*

**I**t is a great honor to assume the duties of president of the Law School Association.

First, I want to thank all of the alumni who gave so generously of their resources to support the University of Georgia School of Law during the fiscal year that just ended. We were successful in reaching our fundraising goal but, in these challenging times, it is important that we maintain our momentum in the coming year.

The university's Archway to Excellence Campaign has just concluded. The law school raised nearly \$20 million, which surpassed its campaign goal of \$17 million

by a significant margin. This money will primarily be used to continue to attract the best and the brightest to Georgia Law by increasing the amount that can be spent on scholarships as well as expanding and enhancing our educational programming. Additionally, these funds will be used to recruit and retain outstanding faculty, which greatly enriches the academic environment at our law school.

At a recent alumni function, I was asked by a fellow alumnus what he could do to help the law school. The easy answer is to make a donation, whether large or small, to the Law School Fund.

Your gift is vital in providing the necessary resources our alma mater needs to compete in attracting top students to Athens. Frequently, these outstanding students are offered large scholarships and other incentives to attend other top law schools in our country and sometimes "bidding wars" ensue. We cannot afford to lose these talented students, particularly Georgia residents, to competing schools. Last year, nearly 85 percent of the entering class called the Peach State home.

Almost 75 cents of every dollar contributed this year was spent on our students with the bulk going to scholarships. Our

goal for the Law School Fund for the coming year is \$700,000, and we are counting on your support.

Dr. Giles Kennedy, who served the last 26 years as the law school's admissions director, retired in December. The new admissions director Paul Rollins, a Yale law school graduate, assumed this post on April 1. He is assisted by Georgia Law graduates Greg Roseboro (J.D.'87), the associate director of admissions since 2000, and Ramsey Henderson Bridges (J.D.'05), who serves as assistant director.

I want alumni to send a powerful message to our new admissions director that he can count on us to provide the needed scholarship dollars that he and his team need to take our law school to the next level. What better time than the present to get behind something we all truly believe in – our law school, the University of Georgia School of Law.

It is exciting to think what the future holds for the University of Georgia School of Law.
