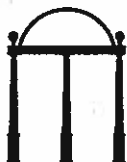


Dear 1987-1988 Graduate:
