

SUMMARY

Academic year 1976-77 was a year of renewal and rededication for the University of Georgia School of Law. With the appointment of a permanent dean on October 13, 1976, the law faculty and the administration embarked upon the task of assessing past progress against prior objectives and the redefining of future goals. This process included a three-year blueprint for progress which is included as Appendix A to this report. What follows is a summary of the present state of the Law School together with comments on some future projections.

Students

The demand for a legal education at the University of Georgia remains strong. This is clear when viewed in the context of admissions statistics for the past ten years.

As the above chart illustrates, the quality of applicants remains high. The 220 students admitted for the fall of 1977 have a projected undergraduate grade point average of 3.40 and a Law School Admission Test score of 636. Those admitted come from more than 1,300 applicants, and the first year class will include 55 women and 12 minority students.

The Law School's admissions process was subjected to special scrutiny during this past year. A resolution passed by the Council of Superior Court Judges of Georgia on October 29, 1976 provided in part as follows:

. . . WHEREAS, The Judges are concerned that admission to the University Law School is based primarily upon the applicant's intellect and the results of pre-admission examinations and that insufficient consideration is given to such essential characteristics as soundness of will and adequate moral values as well as the applicant's overall college performance. . .

NOW THEREFORE BE IT RESOLVED by the Council of Superior Court Judges, in assembly, that the State Bar of Georgia is requested to study the admission practices of the University of Georgia Law School and the practices of other accredited law schools in the State, and made such recommendations concerning admissions as would be in the best interest of the legal profession and the University System.

Georgia State Bar President Harold Clarke referred the above resolution to the Legal Education and Admissions to the Bar Committee for consideration. This committee compiled a report on the admissions practices of the three accredited law schools in Georgia and its chairman issued this statement: "The committee members feel that the present admissions procedures are satisfactorily serving the needs of the legal profession in the State of Georgia."

In addition to the Superior Court Judges' resolution, the Civil Rights Commission's Advisory Committee for Georgia examined the Law School's admissions policies from an affirmative action perspective and while not issuing a formal report expressed in conference that they were consistent with public policy in this area. The present admissions policies involve the consideration of many factors, i.e., those discussed by Justice Douglas in *DeFunis v. Odegaard* in addition to the academic average and LSAT score. According to Vaughn C. Ball, a member of the Georgia faculty and a member of the Law School Admission Council's Test Development and Research Committee, the Georgia admissions process is consistent with the procedures used by most quality law schools throughout the country.

In an effort to attract qualified Black law students to Georgia, the Law School this year conducted the CLEO Institute for the Southeastern

United States. This summer tutorial program is supported in part by the host school and by the Council of Legal Opportunity (CLEO) of the U.S. Department of Health, Education and Welfare. The institute, which served 35 students from academically and economically depressed backgrounds, was directed by Assistant Professor Larry E. Blount of the Georgia law faculty.

The attrition rate for these increasingly well qualified entering students continues a decreasing trend. A twelve year summary of the student retention rate for entering classes which complete three years of law study is as follows:

Georgia students continue to do well on the Georgia State Bar Examination. Of the 62 students who took the bar in July, 1976, 100 per cent passed. Of the 155 candidates who sat for the examination in the February this year, 149 completed the test successfully. This was a 96 per cent passing rate.

Of concern to the Law School's faculty is the impact of the early bar examination provisions, which allow a student to take the Georgia Bar examination after completing seven quarters of law school course work. It is believed by many both at the Georgia Law School and the other two accredited law schools in Georgia, that these provisions are extremely disruptive of the third year academic program. This matter is being studied by a faculty committee with a view toward recommending to the Georgia Supreme Court that these provisions be revised. Also, among the policies considered by the Law School's faculty-student committee on educational programs is the question of whether the current number of credit hours required for graduation -- 135 -- is too high. This number is well above the minimum

standards set by the American Bar Association for accreditation as well as the number required by quality law schools. This matter will be considered by the faculty during the upcoming academic year.

Financial assistance available to students has increased over the years as indicated in the chart below. However, only one fourth of those requesting financial aid are able to obtain it.

Faculty

This past year has been a vigorous one for faculty recruitment. The student-faculty ratio was 28-1 in the fall of 1976. Additional faculty recruited this year will bring the ratio down to 21-1 in 1977-78. The optimum ratio is 15-1.

Two new associate professors have joined the law faculty this summer on a permanent basis. Eric M. Holmes comes to Athens from his position as associate professor at the University of Pittsburgh School of Law. He will teach contracts, insurance and commercial paper. Holmes earned the LL.M. degree at Columbia University in 1975. Fredrick W. Huszagh, recently a visiting associate professor at the University of Wisconsin, will teach torts and international law. Formerly director of the Law and Social Science Program of the National Science Foundation, Huszagh holds the J.S.D. degree from the University of Chicago. Huszagh will work as executive director of the Rusk Center as well as teach.

The Francis Shackelford Chair in Taxation will be filled beginning with the fall quarter of 1977. John C. O'Byrne, presently dean of the School of Law of Northeastern University, will become the first Shackelford Professor. O'Byrne taught on the law faculties of Northwestern University and the University of Iowa before assuming the deanship at Northeastern. He was the founder and director of the Agricultural Law Center at the University of Iowa. He holds a graduate degree in public administration and completed his law studies at Harvard in 1948.

The Francis Shackelford Chair in Taxation was established in 1974 through memorial contributions from friends of the Shackelford family. Shackelford, a partner in the law firm of Alston, Miller, and Gaines, died in November, 1973. He served as chairman of the Board of Trustees of the

Loridans Foundation, an endowment fund which supports the Law School's Sibley Lecture Series and the Sibley and Alston professorships in law.

Joining the teaching staff on a visiting basis will be Professors Allan Smith, Peter Coogan, Carl Hawkins, and Milner Ball. Smith is the former law dean and vice-president for Academic Affairs at the University of Michigan, where he is now professor of law. Smith will teach first year courses in property. Coogan, a partner in the Boston firm of Ropes and Gray, is a lecturer at Harvard Law School where he teaches commercial law. Hawkins, currently professor at Brigham Young, taught at Michigan 16 years. A former clerk to U.S. Supreme Court Justice Fred M. Vinson, Hawkins teaches civil procedure and torts. Ball, a graduate of the Georgia Law School, is presently professor at Rutgers, Camden, New Jersey. Ball was editor-in-chief of the Georgia Law Review in 1971. He will teach in the international law area as well as devote time to a comprehensive study of the impact on state laws of the proposed Law of the Sea treaty.

Three present and former deans are teaching classes at Georgia this summer. Ben Johnson, former dean of Emory, Ray Forrester, former dean of Tulane, Vanderbilt and Cornell, and Wiley Davis, Dean of the University of Arkansas, Fayetteville, are visiting professors for the summer session.

A practitioner-in-residence program was initiated this year as one element of an expanded clinical offering. Hamilton Lokey, an Atlanta attorney with outstanding experience in the trial area, visited the campus during the spring quarter. He taught a section of the trial practice course along with Athens attorney Davison Burch; conducted a series of small group seminars on trial preparation and ethics, and taught counseling skills to the Legal Aid clinical program. The practitioner-in-residence

program was highly successful in its first year of operation. It served to enrich the traditional curriculum and thus make the transition from student to practitioner a more meaningful one.

The Georgia law faculty continued this past year to receive recognition both regionally and nationally. Assistant Professor Albert M. Pearson was named reporter for the revision of the American Bar Association's Standards Relating to Fair Trial and Free Press. Professor William Futrell was elected national president of the Sierra Club. Professor Ronald Ellington was elected to membership in the American Law Institute. Professor Perry Sentell's Studies in Georgia Local Government Law was published in the third edition this year as was the second edition of the Uniform Probate Code Practice Manual by Professor Richard Wellman.

This year has been a good one for state support for the law school. The year began with a high student-faculty ratio, and the School ranked near the bottom regionally for assistant professor salaries. Much has been done to remedy this situation. The President of the University has supported this Law School to the fullest measure possible. Not only will the student-faculty ratio be greatly reduced next year but the salary structure is now very competitive. The over all state budget was increased markedly.

Law Library

The law library now holds 235,626 volumes of conventional books, plus the equivalent of 33,907 more in microfilm. For several years this library has ranked 20th in size among the 167 accredited U. S. law school libraries in terms of volume count. Between 1965 and 1969 special funds amounting to \$1,000,000 in addition to normal allocations enabled the library to acquire all worthwhile titles in Anglo-American and public

international law then in print, in reprinting or to be found by an intensive, systematic search of the used book markets.

Inflation which caused library costs to increase by 89 percent since 1969 has eroded some of the gains made during the 1960s. This year President Davison allocated to the law school library \$47,000 as a special inflation supplement. This brought the law library's total allocation to \$260,000 excluding binding costs. This special supplement stopped the erosion and permitted a catch-up in several vital areas.

Plans to expand the library have received approval from the university administration and the University System Board of Regents. At its June meeting the Board of Regents approved the appointment of the architectural firm of Jova, Daniels and Busbee to design a new library addition. This addition, which will be located across Herty Drive from the present library structure, will be designed to accommodate 150,000 additional volumes as well as needed office and related space. Also, plans are being made to develop a Talmadge library to house the papers of Georgia's senior Senator. Senator Talmadge recently agreed to give his papers to the Georgia law school.

This year will be the last year of service for Law Librarian Sewell Brumby. Professor Brumby will retire after more than a decade of service in developing and administering this fine collection of materials. During Professor Brumby's tenure the law library has expanded from 42,000 volumes to 235,626.

Physical Plant

One measure of a Law School's quality is its physical plant facilities. This year, the entire Law Building was totally utilized. Every available inch of space was occupied, and in many instances, space had

to be reallocated to accommodate the growing needs of the School. In addition to the library annex, plans are underway to add additional space to the existing structure to provide permanent housing for the Dean Rusk Center for International and Comparative Law and the Institute for Continuing Legal Education and the recently established Judicial College. Tentative plans call for this addition to be located on the south side of the existing structure.

In October the Dean Rusk Center for International and Comparative Law will be dedicated. This interdisciplinary center has among its goals the realization of the enormous potential for trade and investment between the State of Georgia and the foreign community by providing legal solutions and alternatives to problems inhibiting trade and investment; and, leadership and policy-making in this area of international law at all levels of the public and private sectors. A special Center Planning Committee has worked throughout this year to develop and refine the Center's program which will begin operations in the renovated Waddell Hall on North Campus. The Center will be housed there until the Law Building annex is constructed.

Miscellaneous

To better serve the student affairs area in general and the placement functions of the School in particular, a new administrative position directing both job placement and student affairs was created in January of this year. This change also greatly facilitated the expansion in the alumni relations and fund raising area.

The year was highlighted with special events. Distinguished world scholars such as H.L.A. Hart, former holder of the Chair in Jurisprudence at Oxford, visited the Law School under the auspices of the John A. Sibley lecture series. The Honorable Frank M. Johnson, Jr., U. S. judge for the

Middle District of Alabama, delivered the Sibley lecture during the winter quarter, and Lawrence M. Friedman, Stanford law professor and author of History of American Law, lectured in the fall.

The keynote speaker for Law Day, 1977 was U. S. Secretary of State Cyrus Vance, whose visit to Athens was his first public speaking engagement since assuming his post in January. Governor George Busbee was the Law School Association luncheon speaker, and Senator Herman Talmadge spoke at the ceremony marking the presentation of Mr. John Sibley's portrait to the School of Law.

A survey team from Order of the Coif visited the School of Law in May. This national law honorary society is the "Phi Beta Kappa" of legal education. The team and Coif's Executive Committee recommended Georgia's selection for an Order of the Coif Chapter. Pending a vote by the fifty-six existing chapters this fall, the charter should soon be granted.

In June of this year the Law School was named as the site of the new Judicial College for the state's judiciary. The College will provide continuing legal education for Georgia's judges. An administrator is being hired to establish the program for the college.

The foregoing accomplishments are outward symbols of the School's progress in its advancement toward true excellence. In the last analysis, however, the margin of difference between good and excellent in legal education is determined by the amount of private support received. The progress over the past ten years is in large measure due to greatly increased state resources plus key private support from the Loridans Foundation. The progress of the next ten years will depend largely on a vastly expanded program of private support.

Georgia need ever leave his state because a superior legal education is available elsewhere." Because its first duty is to prepare men and women for the legal profession, the Law School stresses excellence in teaching and research. The School recognizes the diverse aspects of the practice of law in our society; it constantly reviews and adjusts its curriculum to impart a broad understanding of the nature of the legal system; and it seeks to develop in its students analytical and intellectual skills necessary for effective participation in the profession.

Such a purpose also demands a commitment to the standards of excellence that have traditionally been viewed as an elusive goal. The continued support of University President, administration, and the Board of Regents will enable the School of Law to continue its quest for eminence as an aggressive, innovative leader in legal education and law reform, and as a school of prominence and promise to its state and nation.

Salaries for assistant professors have risen drastically in the last few years and are now competitive on a regional basis. Full professor and chairholder positions remain very competitive with most of the prestigious schools nationally.

Table VI depicts the faculty strength increase in the last eight years. The 33% increase has enabled the student/faculty ratio to be reduced to 21:1.

Overall expenditures have risen by \$573,669 or 41%. This increase can be attributed largely to faculty salary increases. The percentage of total expenditures by category, however, has remained virtually unchanged (faculty salaries 80%; non-faculty salaries 12%; operating expenses 8%). Student enrollment in the same eight year period increased most dramatically from the 1970-72 period to 1973. Enrollment has been stabilized at approximately 610-630 and should remain there in the next few years. Total per student expenditures have increased to \$2,266 which represents a 34% increase since 1970.

Chart II shows the average salary for the teaching faculty over the last eight years. The increase of \$5,696 represents an increase of 27%. The greatest strides have been made at the assistant professor level. Chart III demonstrates the current average salaries by professional grade.
