## How to Apply

Candidates for the M.S.L. must have earned a bachelor's degree from an accredited institution before enrolling.

### Applicants Must Submit the Following Documents:

- Application form
- Official transcripts and proof of bachelor's degree
- Personal statement of approximately 500 words that indicates why you wish to attend the M.S.L. program
- A current résumé or CV
- Two (2) letters of recommendation
- Standardized test score: Acceptable tests include LSAT, GMAT, MCAT or GRE\*

Additionally, an interview with an admissions officer is required.

### Additional Information About the M.S.L. Program

The M.S.L. can be completed at the University of Georgia School of Law in Athens, its facility in Atlanta, or a combination of the two locations.

All students enrolled in the M.S.L. program are required to take a three-hour introductory course on the American legal system. Additional courses to fulfill the degree requirement are selected based on interest and availability.

While earning the M.S.L. degree does not make you eligible to take the bar exam or practice law, it does provide an advantage that can be leveraged for success across a broad range of industries.

## Annual Tuition and Costs

The University of Georgia School of Law offers the M.S.L. at a competitive cost, providing a high return on investment for this valuable degree.

### In-state

**FULL-TIME\***– 30 credit hours in one academic year.

**Tuition & Fees: \$17,977**

**PART-TIME\***– 30 credit hours, up to three years.

**Tuition: \$702/credit hour**

**Fees: \$1,133/semester**

### Out-of-state

**FULL-TIME\***– 30 credit hours in one academic year.

**Tuition & Fees: \$38,763**

**PART-TIME\***– 30 credit hours, up to three years.

**Tuition: \$1,543/credit hour**

**Fees: \$1,133/semester**

\* Students are classified as full-time when they enroll in 12–17 credit hours for fall or spring semesters. If a student enrolls in less than 12 credit hours, he or she will be considered a part-time student.
