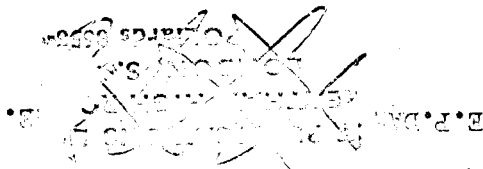

PRE-1865 - LAW REPORTS

1. These series of Law Reports for England and Wales comprising nearly 350 volumes have not been reprinted in the English Reports (reprint). Except for a few scarce specialised series which are being included, they cover a period before the commencement of the Law Reports in 1865. Although a number of these reporters were given in the Revised Reports, their inclusion there was quite incomplete, the normal practice being to give only a few cases from any volume. These volumes have, therefore, been satisfactorily available only in their original form. The number of copies printed at publication was never large and normally very small by modern needs. In recent years, they have become almost unobtainable. There is, moreover, no foreseeable prospect of anything more than an odd copy of a volume coming on to the market occasionally, and reprinting would be quite uneconomic.

2. There has been a continuing demand from many law libraries for these early Law Reports. Their absence in almost all law libraries has long constituted a serious gap in facilities for legal research. Most of the volumes constitute English Common Law sources at a time when American courts were much more directly dependent on English precedent than is the case at the present time. To fill this need in the only practicable manner, arrangements have been completed for these Reports to be reproduced on microcard. Details of the Reports which it is planned to include are given in the following pages. They will comprise more than 200,000 pages.

3. The microcards will be available to subscribers over a 3 year period at a subscription price of £100. a year. *Now HAVE COMPLETE SET*

4. Subscriptions will be payable yearly in advance and the cards themselves will be produced in three approximately equal parts each year. It is anticipated that first deliveries will begin 6 months after the
